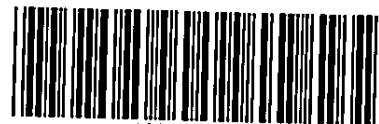

The Directors present their report and the unaudited financial statements for the year ended 31 March 2010

REVIEW OF THE COMPANY AND ITS ACTIVITIES

The Company is a party to the Arlanda consortium contract. There are still outstanding obligations to be closed out under this contract relating to endemic and epidemic warranty claims. Any such obligations are borne by a fellow subsidiary and consequently there is no profit or loss account. The Company has therefore been dormant as defined in section 1169 of the Companies Act 2006 throughout the current and preceding financial year. It is anticipated that the Company will remain dormant for the foreseeable future. Key performance indicators are not considered necessary for an understanding of the development, performance or position of the business of the Company. There are no other risks or uncertainties facing the Company including those within the context of the use of financial instruments.

DIRECTORS AND THEIR INTERESTS

The Directors who held office during the year and subsequently are noted on page 1.

None of the Directors had a beneficial interest, other than in the normal course of business, in any contract to which the Company was a party during the year.

According to the register kept by the Company, as at 31 March 2010 none of the Directors had any disclosable interests in the shares or debentures of the Company or its ultimate parent Company at any time during the year.

During the year the Company has maintained the grant of an indemnity to one or more of its directors against liability in respect of proceedings brought by third parties, subject to the conditions set out in the Companies Act 2006. Such qualifying third party indemnity provision remains in force as at the date of approving the Directors' report.
