

Accounting Convention

These financial statements have been prepared under the historical cost convention.

Foreign Currencies

Assets and liabilities denominated in foreign currencies are translated to sterling at the Balance Sheet date.

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction. All differences are taken to profit and loss account.

Depreciation

No provision for depreciation has been made in respect of the expenditure on patents and trade marks during the year ended 24th December 1998. The Directors consider, following an impairment review that the value of these assets to be equivalent to their cost at that date.
