ON A POLL, EVERY MEMBER WHO (BEING AN INDIVIDUAL) IS PRESENT IN PERSON OR BY A PROXY OR (BEING A COMPANY) BY A REPRESENTATIVE OR BY A PROXY SHALL HAVE ONE VOTE FOR EVERY ORDINARY SHARE OF WHICH HE IS THE HOLDER. INCOME SUMS WHICH THE COMPANY MAY RESOLVE TO DISTRIBUTE IN OR IN RESPECT OF ANY FINANCIAL YEAR SHALL BE APPORTIONED AMONGST THE MEMBERS IN PROPORTION TO THE NUMBERS OF SUCH ORDINARY SHARES HELD BY THEM RESPECTIVELY. CAPITAL ON A RETURN OF CAPITAL ON LIQUIDATION OR OTHERWISE THE SURPLUS ASSETS OF THE COMPANY REMAINING AFTER PAYMENT OF ITS LIABILITIES SHALL BE APPLIED: (A) FIRST, IN REPAYING TO THE MEMBERS THE AMOUNT PAID OR CREDITED AS PAID (INCLUDING BY WAY OF PREMIUM) IN RESPECT OF EACH ORDINARY SHARE HELD; AND (B) SECOND, THE BALANCE (IF ANY) SHALL BE DISTRIBUTED AMONGST THE MEMBERS IN PROPORTION TO THE NUMBERS OF SUCH ORDINARY SHARES HELD BY THEM RESPECTIVELY.
