

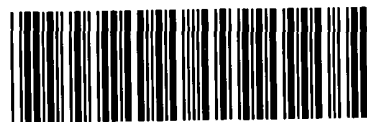


**Accountants' report to the director on the preparation of the


