### Notes to the financial statements

### 1. Director's advances, credits and guarantees

During the year the director advanced the company £10,679 (2016 - £10,258) and the company repaid £nil (2016 - £25,127) to the director. As at 31 March 2017 the company owed the director £18 (2016 - the director owed the company £10,661). Transactions with the director are unsecured, interest free and repayable on demand.

### 2. Employee numbers

The average number of persons employed by the company during the year amounted to 1 (2016 - 1).

### 3. Transition to FRS 105

FRS 105 requires that investment properties are carried at cost rather than a valuation, as reported previously under FRSSE. This change has been retrospectively applied, leading to the removal of the revaluation reserve of £532,531 as at the date of transition. Capital and reserves have been restated by £532,531 at 1 April 2015 and 31 March 2016.

For the year ending 31 March 2017 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.
