1 INTRODUCTION

- 1.1 The model articles for private companies limited by shares contained or incorporated in Schedule 1 to the Companies (Model Articles) Regulations 2008 (SI 2008/3229) as amended prior to the date of adoption of these articles (the "Model Articles") shall apply to the Company, save insofar as they are varied or excluded by, or are inconsistent with, the following Articles.
- 1.2 In these Articles and the Model Articles any reference to any statutory provision shall be deemed to include a reference to each and every statutory amendment, modification, re-enactment and extension thereof for the time being in force.
- 1.3 In these Articles:
- 1.3.1 article headings are used for convenience only and shall not affect the construction or interpretation of these Articles;
 - 1.3.2 words denoting the singular include the plural and vice versa and reference to one gender includes the other gender and neuter and vice versa;
 - 1.3.3 Articles 8(2), 9(4), 10(3), 11(2), 13, 14, 17(2), 17(3), 19, 21, 26(5), 27, 28, 29, 30(5) to (7) (inclusive), 44(4), 51, 52 and 53 of the Model Articles shall not apply to the Company;
 - 1.3.4 reference to "issued Shares" shall exclude any Shares held as Treasury Shares from time to time, unless stated otherwise; and
 - 1.3.5 reference to the "holders" of Shares shall exclude the Company holding Treasury Shares from time to time, unless stated otherwise.
- 1.4 In respect of any actions or matters requiring or seeking the acceptance, approval, agreement, consent or words having similar effect of a Founder Director under these Articles, if at any time a Founder Director has not been appointed or a Founder Director declares in writing to the Company and the Founder that he considers that providing such consent gives rise or may give rise to a conflict of interest to his duties as a Director, such action or matter shall require Founder Consent.

2 DEFINITIONS

In these Articles the following words and expressions shall have the following meanings:

"A Ordinary Shares" means the A ordinary shares of £1.00 each in the capital of the Company from time to time.

"Act" means the Companies Act 2006 (as amended from time to time).

"Acting in Concert" has the meaning given to it in The City Code on Takeovers and Mergers published by the Panel on Takeovers and Mergers (as amended from time to time).

"Actions" shall have the meaning given in Article 6.5.

"**Advisers**" has the meaning given in the Subscription and Shareholders' Agreement.

"Allocation Notice" shall have the meaning given in Article 12.8.

"Applicant" shall have the meaning given in Article 12.8.

"Appointer" shall have the meaning given in Article 21.1.

"Arrears" means in relation to any Share, all arrears of any dividend or other sums payable in respect of that Share, whether or not earned or declared and irrespective of whether or not the Company has had at any time sufficient Available Profits to pay such dividend or sums, together with all interest and other amounts payable on that Share.

"Asset Sale" means the disposal by the Company of all or substantially all of its undertaking and assets (where disposal may include, without limitation, the grant by the Company of an exclusive licence of intellectual property not entered into in the ordinary course of business).

"Associate" in relation to any person means:

- (a) any person who is an associate of that person and the question of whether a person is an associate of another is to be determined in accordance with section 435 of the Insolvency Act 1986 and (whether or not an associate as so determined); and
- (b) any Member of the same Group.

"Auditors" means the auditors of the Company from time to time.

"Available Profits" means profits available for distribution within the meaning of part 23 of the Act.

"B Ordinary Shares" means the B ordinary shares of £0.10 each in the capital of the Company from time to time.

"Bad Leaver" means a person who ceases to be an Employee and who is not a Good Leaver.

"Board" means the board of Directors and any committee of the board constituted for the purpose of taking any action or decision contemplated by these Articles.

"Board Invitee" means any person as the Board, with Founder Consent, may nominate.

"Business Day" means a day on which English clearing banks are ordinarily open for the transaction of normal banking business in the City of London (other than a Saturday or Sunday).

"Buyer" has the meaning set out in Article 16.2.

"C Ordinary Shares" means the C ordinary shares of £0.10 each in the capital of the Company from time to time.

"Call Notice" shall have the meaning given in Article 32.

"Called Shareholder" has the meaning set out in Article 17.1.

"Called Shares" shall have the meaning given in Article 17.3.

"Capitalised Sum" shall have the meaning given in Article 35.

"Co-Sale Shareholder" has the meaning set out in Article 16.2.

"Co-Sale Notice" has the meaning set out in Article 16.2.

"Company" means Bon Voyage Travel & Tours Limited.

"Company's Lien" has the meaning given in Article 31.1.

"Connected Person" shall have the meaning attributed to that term by sections 1122 and 1123 of the CTA 2010.

"Continuing Shareholders" has the meaning given in Article 12.7.

"Controlling Interest" means an interest in shares giving to the holder or holders control of the Company within the meaning of section 1124 of the CTA 2010.

"CTA 2010" means the Corporation Tax Act 2010.

"Date of Adoption" means the date on which these Articles were adopted.

"Deed of Adherence" has the meaning given in the Subscription and Shareholder's Agreement.

"Director(s)" means a director or directors of the Company from time to time.

"Drag Along Notice" shall have the meaning given in Article 17.3.

"Drag Along Option" has the meaning set out in Article 17.1.

"Drag Completion Date" has the meaning given in Article 17.7.

"Drag Consideration" has the meaning given in Article 17.5.

"Drag Documents" has the meaning given in Article 17.7.

"Drag Purchaser" has the meaning set out in Article 17.1.

"Effective Termination Date" means the date on which the Employee gives or is given notice to terminate his employment or consultancy.

"electronic address" has the same meaning as in section 333 of the Act.

"electronic form" and "electronic means" have the same meaning as in section 1168 of the Act.

"Eligible Director" means a Director who would be entitled to vote on a matter had it been proposed as a resolution at a meeting of the Directors.

"Employee" means any individual who is employed by or who provides consultancy services to, the Company or any member of the Group, but excluding the Advisers, the Founder and any of the Founder's Permitted Transferees.

"Employee Shares" in relation to an Employee means all (or such lower number as may be agreed by the Founder and the Board pursuant to Article 15.1) Ordinary Shares held by:

- (a) the Employee in question and their Permitted Transferee; and
- (b) any Permitted Transferee of that Employee, other than those Shares held by those persons that the Founder is satisfied were not acquired directly or indirectly from the Employee or by reason of that person's relationship with the Employee;

"Encumbrance" means any mortgage, charge, security, interest, lien, pledge, assignment by way of security, equity, claim, right of pre-emption, option, covenant, restriction, reservation, lease, trust, order, decree, judgment, title defect (including without limitation any retention of title claim), conflicting claim of ownership or any other encumbrance of any nature whatsoever (whether or not perfected other than liens arising by operation of law).

"Equity Holder" has the meaning set out in Article 16.2.

"Equity Securities" has the meaning given in sections 560(1) to (3) inclusive of the Act and for the avoidance of doubt an allotment of Equity Securities includes a transfer of shares which immediately before such transfer were held by the Company as Treasury Shares.

"Exit" means a Share Sale, an Asset Sale or an IPO.

"Expert Valuer" is as determined in accordance with Article 13.2.

"Fair Value" is as determined in accordance with Article 13.

"Financial Year" has the meaning set out in section 390 of the Act.

"Family Member" means, in relation to a Shareholder (or a deceased or former Shareholder) (i) a spouse or civil partner (as defined in the Civil Partnerships Act 2004), (ii) a child or grandchild (including step or adopted or illegitimate child) and their issue and (iii) a brother, sister, niece or nephew.

"Family Trust" means, in relation to a Shareholder, a trust or settlement set up wholly for the benefit of that person and/or his Family Members including a self-invested personal pension scheme which is a registered scheme within the meaning of the Finance Act 2004.

"Founder Consent", and any other reference in these Articles to the Founder making a determination in respect of any matter, means the prior written consent of the Founder or, if there is more than one

Founder, the prior written consent of the holders of more than 50% in nominal value of the total number of Shares held by them.

"Founder Director Consent" means the prior written consent of the Founder Director.

"Founder Director" means the director of the Company nominated by the Founder under Article 23.1.

"Founder" shall have the meaning give to it in the Subscription and Shareholders' Agreement and each of his Permitted Transferees.

"Good Leaver" means a person who ceases to be an Employee by reason of:

- (a) death (other than as a result of drink and/or drug dependency);
- (c) ill health (other than as a result of drink and/or drug dependency) where in the reasonable opinion of the Board (with Founder Consent) the condition is sufficiently serious to prevent such Leaver from continuing their duties as an Employee of the Group; or
- (d) any other circumstances where the Board (with Founder Consent) agree in writing that such Employee should be a Good Leaver.

"Group" means the Company and its Subsidiary Undertaking(s) (if any) from time to time and "Group Company" shall be construed accordingly.

"hard copy form" has the same meaning as in section 1168 of the Act.

"Holding Company" means a newly formed holding company, pursuant to which the membership, pro rata shareholdings and classes of shares comprised in such holding company matches that of the Company (excluding Treasury Shares) immediately prior to the transfer of the issued share capital of the Company to such holding company.

"Issue Price" in relation to a Share, means (subject to Article 15.3) the paid-up nominal value (excluding any share premium).

"IPO" means the admission of all or any of the Shares or securities representing those shares (including without limitation depositary interests and/or other instruments) on the Official List of the United Kingdom Listing Authority or the AIM Market operated by the London Stock Exchange Plc or any other recognised investment exchange (as defined in section 285 of the Financial Services and Markets Act 2000).

"ITEPA" means Income Tax (Earnings and Pensions) Act 2003.

"Lien Enforcement Notice" has the meaning given in Article 31.3.

"Majority Consent" means the consent of both (a) the holders of more than 50% of the aggregate of the A Ordinary Shares and the B Ordinary Shares (treated as one class of share for the purpose of this calculation) and (b) the holders of more than 50% of the C Ordinary Shares, in each case from time to time.

"a Member of the same Group" means as regards any company, a company which is from time to time a Parent Undertaking or a Subsidiary Undertaking of that company or a Subsidiary Undertaking of any such Parent Undertaking.

"Minimum Transfer Condition" has the meaning given in Article 12.2.

"New Securities" means any shares or other securities convertible into, or carrying the right to subscribe for, those shares issued by the Company after the Date of Adoption (other than shares or securities issued as a result of the events set out in Article 9) excluding any Treasury Shares transferred by the Company after the Date of Adoption.

"New Shareholder" has the meaning set out in Article 17.12.

"Offer Period" has the meaning set out in Article 12.7.

"Ordinary Shares" means the A Ordinary shares, the B Ordinary Shares and the C Ordinary Shares.

"Original Shareholder" has the meaning set out in Article 11.2.

"Permitted Transfer" means a transfer of Shares in accordance with Article 11.

"Permitted Transferee" means, in respect of any Shareholder:

- (a) a person to whom such Shareholder is permitted to transfer Shares under Article 11; and
- (b) any person approved as such by Founder Consent

"Primary Holder" has the meaning set out in Article 27.8.

"Priority Amount" has the meaning set out in Article Error! Reference source not found..

"Priority Rights" means the rights of Shareholders to purchase Shares contained in a Transfer Notice in the priority stipulated in Article 12.6.

"Proceeds of Sale" means the consideration payable (including any deferred or contingent consideration) whether in cash or otherwise to those Shareholders selling Shares under a Share Sale less any fees, costs and expenses payable in respect of such Share Sale as approved by the Founder.

"Proposed Exit" has the meaning given in Article 6.5.

"Proposed Purchaser" means a proposed purchaser who is not a Connected Person of any Shareholder and who at the relevant time has made a bona fide offer on arm's length terms.

"Qualifying Person" has the meaning given in section 318(3) of the Act.

"Recipient" has the meaning set out in Article 29.

"Recipient Group Companies" has the meaning set out in Article 29.

"Relevant Interest" has the meaning set out in Article 26.4.

"Remaining Assets" has the meaning given in Article 5.1.

"Sale Agreement" has the meaning given in Article 17.3.

"Sale Shares" has the meaning set out in Article 12.2.1.

"Seller" has the meaning set out in Article 12.2.

"Sellers' Shares" has the meaning set out in Article 17.1.

"Selling Shareholders" has the meaning set out in Article 17.1.

"Shareholder" means any holder of any Shares (but excludes the Company holding Treasury Shares).

"Shareholders Entitled" shall have the meaning given in Article 35.

"Shares" means the Ordinary Shares and any other shares or equity securities issued by the Company from time to time.

"Share Sale" means the sale of (or the grant of a right to acquire or to dispose of) any of the shares in the capital of the Company (in one transaction or as a series of transactions) which will result in the purchaser of those shares (or grantee of that right) and persons Acting in Concert with him together acquiring a Controlling Interest in the Company, except where following completion of the sale the shareholders and the proportion of shares held by each of them are the same as the shareholders and their shareholdings in the Company immediately prior to the sale.

"Subscription and Shareholders' Agreement" means the subscription and shareholders' agreement dated on or around the Date of Adoption between, amongst others, the Company and the Founder.

"Subsidiary", "Subsidiary Undertaking" and "Parent Undertaking" have the respective meanings set out in sections 1159 and 1162 of the Act.

"Threshold Amount" means £2,000,000 (two million pounds) minus the Priority Amount.

"Transfer Notice" has the meaning given in Article 12.2.

"Transfer Price" has the meaning given in Article 12.2.3.

"Treasury Shares" means shares in the capital of the Company held by the Company as treasury shares from time to time within the meaning set out in section 724(5) of the Act.

3 SHARE CAPITAL

- 3.1 Except as otherwise provided in these Articles, the Ordinary Shares shall rank pari passu in all respects.
- 3.2 The words "and the directors may determine the terms, conditions and manner of redemption of any such shares" shall be deleted from article 22(2) of the Model Articles.
- 3.3 Subject to Founder Consent and the Act, the Company may purchase its own Shares to the extent permitted by section 692(1ZA) of the Act.
- 3.4 Paragraph (c) of article 24(2) of the Model Articles shall be amended by the replacement of the words "that the shares are fully paid; and" with the words "the amount paid up on them; and".
- 3.5 In article 25(2) of the Model Articles, the words "payment of a reasonable fee as the directors decide" in paragraph (c) shall be deleted and replaced by the words "payment of the expenses reasonably incurred by the Company in investigating evidence as the directors may determine".
- 3.6 For the avoidance of doubt, the Company shall not exercise any right in respect of any Treasury Shares, including without limitation any right to:
 - 3.6.1 receive notice of or to attend or vote at any general meeting of the Company;
 - 3.6.2 receive or vote on any proposed written resolution; and
 - 3.6.3 receive a dividend or other distributionsave as otherwise permitted by section 726(4) of the Act.

4 DIVIDENDS

- 4.1 In respect of any Financial Year, the Company's Available Profits will be applied as set out in this Article 4.
- 4.2 Subject to the Act and these Articles, the Board may pay interim dividends if justified by the Available Profits in respect of the relevant period.
- 4.3 In respect of any Available Profits which the Company determines to distribute in respect of any Financial Year, the directors shall have the discretion to declare (or recommend as the case may be) a dividend on one class of Shares but not another class, and to declare (or recommend as the case may be) a different level of dividend on each class of Shares.
- 4.4 Every dividend shall accrue on a daily basis assuming a 365 day year. All dividends are expressed net and shall be paid in cash.
- 4.5 Article 31(1) of the Model Articles shall be amended by:
 - 4.5.1 the replacement of the words "either in writing or as the directors may otherwise decide" at the end of paragraphs (a), (b) and (c) of that article 31(1) with the words "in writing"; and
 - 4.5.2 the replacement of the words "either in writing or by such other means as the directors decide" from the end of paragraph (d) of that article 31(1) with the words "in writing".

5 LIQUIDATION PREFERENCE

- 5.1 On a return of assets on liquidation, capital reduction or otherwise, the assets of the Company remaining after the payment of its liabilities ("Remaining Assets") shall be applied (to the extent that the Company is lawfully able to do so) in the following order of priority:
 - 5.1.1 in priority to any payments to be made pursuant to the remainder of this Article, in distributing the value of the Remaining Assets up to the Threshold Amount among the holders of the A Ordinary Shares, B Ordinary Shares and C Ordinary Shares as follows:
 - 5.1.1.1 as to the holders of the C Ordinary Shares, an amount equal to 12.5%; and

- 5.1.1.2 as to the holders of the A Ordinary Shares and the B Ordinary Shares, an amount equal to 87.5%, pro rata to the total number of A Ordinary Shares and B Ordinary Shares held by them as if they constituted shares of the same class;
- 5.1.2 second, in distributing the value of the Remaining Assets among the holders of the A Ordinary Shares, B Ordinary Shares and C Ordinary Shares as follows:
 - 5.1.2.1 as to the holders of the C Ordinary Shares, an amount equal to 30%; and
 - 5.1.2.2 as to the holders of the A Ordinary Shares and the B Ordinary Shares, an amount equal to 70%, pro rata to the total number of A Ordinary Shares and B Ordinary Shares held by them as if they constituted shares of the same class.

6 EXIT PROVISIONS

- 6.1 On a Share Sale the Proceeds of Sale shall be distributed in the order of priority set out in Article 5 on the basis that the Proceeds of Sale shall be treated as Remaining Assets and the Directors shall not register any transfer of Shares if the Proceeds of Sale are not so distributed save in respect of any Shares not sold in connection with that Share Sale provided that if the Proceeds of Sale are not settled in their entirety upon completion of the Share Sale:
 - 6.1.1 the Directors shall not be prohibited from registering the transfer of the relevant Shares so long as the Proceeds of Sale that are settled have been distributed in the order of priority set out in Article 5 (on the basis that the Proceeds of Sale shall be treated as Remaining Assets); and
 - 6.1.2 each Shareholder shall take any reasonable action (to the extent lawful and within its control) to ensure that the balance of the Proceeds of Sale in their entirety are distributed in the order of priority set out in Article 5 (on the basis that the Proceeds of Sale shall be treated as Remaining Assets).
- 6.2 In the event that the Proceeds of Sale are distributed on more than one occasion (for any deferred or contingent consideration or otherwise), the consideration so distributed on any further occasion shall be paid by continuing the distribution from the previous distribution of consideration in the order of priority set out in Article 5.
- 6.3 The value of Exit Proceeds which represent consideration other than cash payable on completion of a Share Sale shall be an amount reasonably determined by the Directors or, if the Founder requests in his sole discretion, an amount as valued by an independent financial adviser appointed by the Founder.
- 6.4 On an Asset Sale the surplus assets of the Company remaining after payment of its liabilities shall be distributed (to the extent that the Company is lawfully permitted to do so) in the order of priority set out in Article 5 (on the basis that the Proceeds of Sale shall be treated as Remaining Assets) provided always that if it is not lawful for the Company to distribute its surplus assets in accordance with the provisions of these Articles, the Shareholders shall (to the extent lawful and within its control) take any reasonable action (including, but without prejudice to the generality of this Article 6.4, actions that may be necessary to put the Company into voluntary liquidation) so that Article 5 applies.
- 6.5 In the event of an Exit approved by the Board and the Founder in accordance with the terms of these Articles and which has also been approved by the holders of over 50% of the aggregate number of the Ordinary Shares (the "Proposed Exit"), all Shareholders shall consent to, vote for, raise no objections to and waive any applicable rights in connection with the Proposed Exit ("Actions"). The Shareholders shall be required to take all Actions with respect to the Proposed Exit as are required by the Board to facilitate the Proposed Exit. If any Shareholder fails to comply with the provisions of this Article, the Company shall be constituted the agent of each defaulting Shareholder for taking the Actions as are necessary to effect the Proposed Exit and the Directors may authorise an officer or member to execute and deliver on behalf of such defaulting Shareholder the necessary documents and the Company may receive any purchase money due to the defaulting Shareholder in trust for each of the defaulting Shareholders.

7 VOTES IN GENERAL MEETING AND WRITTEN RESOLUTIONS

- 7.1 Each holder of Ordinary Shares shall have the right to receive notice of and to attend, speak and vote at all general meetings of the Company and to receive and vote on proposed written resolutions of the Company.
- 7.2 Where Shares confer a right to vote, on a show of hands each holder of such shares who (being an individual) is present in person or by proxy or (being a corporation) is present by a duly authorised representative or by proxy shall have one vote and on a poll each such holder so present shall have one vote for each Share held by him.
- 7.3 No voting rights attached to a share which is nil paid or partly paid may be exercised:
- 7.3.1 at any general meeting, at any adjournment of it or at any poll called at or in relation to it; or
- 7.3.2 on any proposed written resolution,
- unless all of the amounts payable to the Company in respect of that share have been paid.

8 VARIATION OF RIGHTS

If at any time after the Date of Adoption, the share capital of the Company is divided into different classes of shares, the rights attached to any class may only be varied, modified, abrogated or cancelled only with the consent in writing of the holders of 75% of the issued shares of that class and Founder Consent.

9 ALLOTMENT OF NEW SHARES OR OTHER SECURITIES: PRE-EMPTION

- 9.1 Sections 561(1) and 562(1) to (5) (inclusive) of the Act do not apply to an allotment of Equity Securities made by the Company.
- 9.2 Unless otherwise agreed to in writing with Majority Consent, if the Company proposes to allot any New Securities those New Securities shall not be allotted to any person unless the Company has in the first instance offered them to all holders of Shares (the "Subscribers") on the same terms and at the same price as those New Securities are being offered to other persons on a pari passu and pro rata basis to the number of Shares held by those holders (as nearly as may be without involving fractions). The offer:
- 9.2.1 shall be in writing, be open for acceptance from the date of the offer to the date 10 Business Days after the date of the offer (inclusive) (the "Subscription Period") and give details of the number and subscription price of the New Securities; and
- 9.2.2 may stipulate that any Subscriber who wishes to subscribe for a number of New Securities in excess of the proportion to which each is entitled shall in their acceptance state the number of excess New Securities for which they wish to subscribe.
- 9.3 If, at the end of the Subscription Period, the number of New Securities applied for is equal to or exceeds the number of New Securities, the New Securities shall be allotted to the Subscribers who have applied for New Securities on a pro rata basis to the number of Shares held by such Subscribers which procedure shall be repeated until all New Securities have been allotted (as nearly as may be without involving fractions or increasing the number allotted to any Subscriber beyond that applied for by him).
- 9.4 If, at the end of the Subscription Period, the number of New Securities applied for is less than the number of New Securities, the New Securities shall be allotted to the Subscribers in accordance with their applications and any remaining New Securities shall be offered to any other person as the Directors may determine at the same price and on the same terms as the offer to the Subscribers.
- 9.5 Subject to the requirements of Articles 9.2 to 9.4 (inclusive) and to the provisions of section 551 of the Act, any New Securities shall be at the disposal of the Board who may allot, grant options over or otherwise dispose of them to any persons at those times and generally on the terms and conditions they think proper, provided that the allotment or grant to that person must be approved in writing by the Founder unless it is an allotment to a Subscriber pursuant to Articles 9.3 or 9.4.
- 9.6 No Shares shall be allotted (nor any Treasury Shares be transferred) to any Employee, Director, prospective Employee or prospective director of the Company, who in the opinion of the Board is

subject to taxation in the United Kingdom, unless such person has entered into a joint section 431 ITEPA election with the Company if so required by the Company.

10 TRANSFERS OF SHARES – GENERAL

- 10.1 In Articles 8 to 17 inclusive, reference to the transfer of a Share includes the transfer or assignment of a beneficial or other interest in that Share or the creation of a trust or Encumbrance over that Share and reference to a Share includes a beneficial or other interest in a Share.
- 10.2 No Share may be transferred unless either (i) there is Founder Consent and such transfer is made in accordance with these Articles or (ii) such transfer is made in accordance with Articles 11, 14, 15, 16 or 17 or (iii) such transfer is made in accordance with the Option Agreement.
- 10.3 If a Shareholder transfers or purports to transfer a Share otherwise than in accordance with these Articles he will be deemed immediately to have served a Transfer Notice in respect of all Shares held by him.
- 10.4 Any transfer of a Share by way of sale which is required to be made under Articles 11.1 to 17 (inclusive) will be deemed to include a warranty that the transferor sells with full title guarantee.

- 10.5 The Directors may refuse to register a transfer if:

- 10.5.1 it is a transfer of a Share to a bankrupt, a minor or a person of unsound mind;
- 10.5.2 the transfer is to an Employee, Director or prospective Employee or prospective director of the Company, who in the opinion of the Board is subject to taxation in the United Kingdom, and such person has not entered into a joint section 431 ITEPA election with the Company;
- 10.5.3 it is a transfer of a Share which is not fully paid:
 - 10.5.3.1 to a person of whom the Directors do not approve; or
 - 10.5.3.2 on which Share the Company has a lien;
- 10.5.4 the transfer is not lodged at the registered office or at such other place as the Directors may appoint;
- 10.5.5 the transfer is not accompanied by the certificate for the Shares to which it relates (or an indemnity for lost certificate in a form acceptable to the Board) and such other evidence as the Directors may reasonably require to show the right of the transferor to make the transfer;
- 10.5.6 the transfer is in favour of more than four transferees; or
- 10.5.7 these Articles otherwise provide that such transfer shall not be registered.

If the Directors refuse to register a transfer, the instrument of transfer must be returned to the transferee with the notice of refusal unless they suspect that the proposed transfer may be fraudulent.

- 10.6 The Directors may, as a condition to the registration of any transfer of shares in the Company (whether pursuant to a Permitted Transfer or otherwise), require the transferee to execute and deliver to the Company a deed agreeing to be bound by the terms of the Subscription and Shareholders' Agreement or any shareholders' agreement or similar document in force between some or all of the Shareholders and the Company in any form as the Directors may reasonably require (but not so as to oblige the transferee to have any obligations or liabilities greater than those of the proposed transferor under any such agreement or other document) and if any condition is imposed in accordance with this Article 10.6 the transfer may not be registered unless that deed has been executed and delivered to the Company's registered office by the transferee.
- 10.7 To enable the Directors to determine whether or not there has been any disposal of shares in the capital of the Company (or any interest in shares in the capital of the Company) in breach of these Articles the Directors may, with Founder Director Consent, require any holder or the legal personal representatives of any deceased holder or any person named as transferee in any transfer lodged for registration or any other person who the Directors or the Founder Director may reasonably believe to have information relevant to that purpose, to furnish to the Company that information and evidence the Directors may request regarding any matter which they deem relevant to that purpose, including

(but not limited to) the names, addresses and interests of all persons respectively having interests in the shares in the capital of the Company from time to time registered in the holder's name. If the information or evidence is not provided to enable the Directors to determine to their reasonable satisfaction that no breach has occurred, or where as a result of the information and evidence the Directors are reasonably satisfied that a breach has occurred, the Directors shall immediately notify the holder of such shares in the capital of the Company in writing of that fact and the following shall occur:

- 10.7.1 the relevant shares shall cease to confer upon the holder of them (including any proxy appointed by the holder) any rights to vote (whether on a show of hands or on a poll and whether exercisable at a general meeting or on a written resolution of the Company); or
- 10.7.2 the withholding of payment of all dividends or other distributions otherwise attaching to the relevant shares or to any further shares issued in respect of those shares; and
- 10.7.3 the holder may be required at any time following receipt of the notice to transfer some or all of his Shares to any person(s) at the price that the Directors may require by notice in writing to that holder.

The rights referred to in 10.7.1 and 10.7.2 above may be reinstated by the Board subject to Founder Director Consent and shall in any event be reinstated upon the completion of any transfer referred to in 10.7.3 above.

- 10.8 In any case where the Board requires a Transfer Notice to be given in respect of any Shares, if a Transfer Notice is not duly given within a period of 10 Business Days of demand being made, a Transfer Notice shall be deemed to have been given at the expiration of that period.
- 10.9 If a Transfer Notice is required to be given by the Board or is deemed to have been given under these Articles, the Transfer Notice, unless otherwise specified in the Articles, will be treated as having specified that:
 - 10.9.1 the Transfer Price for the Sale Shares will be as agreed between the Board (including Founder Director Consent) (any director who is a Seller or with whom the Seller is connected (within the meaning of section 252 of the Act) not voting) and the Seller, or, failing agreement within five Business Days after the date on which the Board becomes aware that a Transfer Notice has been deemed to have been given, will be the Fair Value of the Sale Shares;
 - 10.9.2 it does not include a Minimum Transfer Condition (as defined in Article 12.2.4); and
 - 10.9.3 the Seller wishes to transfer all of the Shares held by it.
- 10.10 Shares may be transferred by means of an instrument of transfer in any usual form or any other form approved by the directors, which is executed by or on behalf of:
 - 10.10.1 the transferor; and
 - 10.10.2 (if any of the shares is partly or nil paid) the transferee.
- 10.11 Each Share which is transferred to a person who:
 - 10.11.1 already holds A Ordinary Shares shall, unless such Share is an A Ordinary Share, be automatically converted into an A Ordinary Share immediately on completion of such transfer; and
 - 10.11.2 already holds B Ordinary Shares shall, unless such Share is an B Ordinary Share, be automatically converted into an B Ordinary Share immediately on completion of such transfer; and
 - 10.11.3 already holds C Ordinary Shares shall, unless such Share is an C Ordinary Share, be automatically converted into an C Ordinary Share immediately on completion of such transfer.

11 PERMITTED TRANSFERS

- 11.1 Notwithstanding the provisions of Article 10:

- 11.1.1 the Founder may transfer his Shares to any of his Family Members over the age of 18 or to the trustees of his Family Trust;
- 11.1.2 any Shareholder who is a trustee of a Family Trust may at any time transfer any Share which he holds in that capacity to:
 - 11.1.2.1 the new or remaining trustees of the Family Trust upon any change of trustees; and
 - 11.1.2.2 any of his Family Members over the age of 18 on their becoming entitled to the same under the terms of the Family Trust;
- 11.1.3 any Shareholder holding Shares as a result of a transfer made after the Date of Adoption by the Founder in relation to whom such Shareholder was a Permitted Transferee may at any time transfer any Share to the Founder such Shares (or to any other Permitted Transferee of the Founder)
- 11.2 Notwithstanding the provisions of Article 10, any Shareholder (the "Original Shareholder") may transfer all or any of its Shares to a Permitted Transferee without restriction as to price or otherwise.
- 11.3 Subject to Article 10.7, the Company shall be obliged to register any transfer made pursuant to the above provisions.
- 11.4 Where any Shareholder holding Shares as a result of a transfer made after the Date of Adoption by the Founder in relation to whom such Shareholder was a Permitted Transferee ceases to be such a Permitted Transferee such Shareholder shall, at the Founder's election, immediately transfer all such Shares to the Founder or to any other Permitted Transferee of the Founder.
- 11.5 The transfer of Shares pursuant to the call option contained in clause 21 of the Subscription and Shareholder's Agreement shall be a Permitted Transfer.

12 TRANSFERS OF SHARES SUBJECT TO PRE-EMPTION RIGHTS

- 12.1 Save where the provisions of Articles 11, 16 and 17 apply, any transfer of Shares by a Shareholder shall be subject to the pre-emption rights contained in this Article 11.1.
- 12.2 A Shareholder who wishes to transfer Shares (a "Seller") shall, except as otherwise provided in these Articles, before transferring or agreeing to transfer any Shares give notice in writing (a "Transfer Notice") to the Company specifying:
 - 12.2.1 the number of Shares which he wishes to transfer (the "Sale Shares");
 - 12.2.2 if he wishes to sell the Sale Shares to a third party, the name of the proposed transferee;
 - 12.2.3 the price at which he wishes to transfer the Sale Shares; and
 - 12.2.4 whether the Transfer Notice is conditional on all or a specific number of the Sale Shares being sold to Shareholders (a "Minimum Transfer Condition").

If no cash price is specified by the Seller, the price at which the Sale Shares are to be transferred (the "Transfer Price") must be agreed by the Board (including Founder Director Consent). In addition, if the price is not specified in cash, an equivalent cash value price must be agreed between the Seller and the Board (including Founder Director Consent). In both cases, the price will be deemed to be the Fair Value of the Sale Shares if no price is agreed within five Business Days of the Company receiving the Transfer Notice.
- 12.3 Except with Founder Director Consent, no Transfer Notice once given or deemed to have been given under these Articles may be withdrawn.
- 12.4 A Transfer Notice constitutes the Company the agent of the Seller for the sale of the Sale Shares at the Transfer Price.
- 12.5 As soon as practicable following the later of:
 - 12.5.1 receipt of a Transfer Notice; and

12.5.2 in the case where the Transfer Price has not been agreed, the determination of the Transfer Price under Article 13,

the Board shall offer the Sale Shares for sale to the Shareholders in the manner set out in Articles 12.6 and 12.7. Each offer must be in writing and give details of the number and Transfer Price of the Sale Shares offered.

12.6 Priority for offer of Sale Shares

12.6.1 Sale Shares shall be offered:

12.6.1.1 firstly, to the Company to be bought back and held as Treasury Shares or cancelled;

12.6.1.2 secondly to a Board Invitee; and

12.6.1.3 thirdly, to all Shareholders,

in each case on the basis set out in Article 12.7.

12.7 Transfers: Offer

12.7.1 The Board shall offer the Sale Shares pursuant to the Priority Rights (such persons being the "Continuing Shareholders") inviting them to apply in writing within the period from the date of the offer to the date 10 Business Days after the offer (inclusive) (the "Offer Period") for the maximum number of Sale Shares they wish to buy.

12.7.2 If the Sale Shares are subject to a Minimum Transfer Condition then any allocation made under Article 12.7 will be conditional on the fulfilment of the Minimum Transfer Condition.

12.7.3 If, at the end of the Offer Period, the number of Sale Shares applied for is equal to or exceeds the number of Sale Shares, the Board shall allocate the Sale Shares to each Continuing Shareholder who have applied for Sale Shares in the proportion (fractional entitlements being rounded to the nearest whole number) which his existing holding of the Shares bears to the total number of the Shares held by those Continuing Shareholders who have applied for Sale Shares which procedure shall be repeated until all Sale Shares have been allocated but no allocation shall be made to a Shareholder of more than the maximum number of Sale Shares which he has stated he is willing to buy.

12.7.4 If, at the end of the Offer Period, the number of Sale Shares applied for is less than the number of Sale Shares, the Board shall allocate the Sale Shares to the Continuing Shareholders in accordance with their applications and the balance will be dealt with in accordance with Article 12.8.5.

12.8 Completion of transfer of Sale Shares

12.8.1 If the Transfer Notice includes a Minimum Transfer Condition and the total number of Shares applied for does not meet the Minimum Transfer Condition the Board shall notify the Seller and all those to whom Sale Shares have been conditionally allocated under Article 12.7 stating the condition has not been met and that the relevant Transfer Notice has lapsed with immediate effect.

12.8.2 If:

12.8.2.1 the Transfer Notice does not include a Minimum Transfer Condition; or

12.8.2.2 the Transfer Notice does include a Minimum Transfer Condition and allocations have been made in respect of all or the minimum required number of the Sale Shares,

the Board shall, when no further offers are required to be made under Article 12.7 and once the requirements of Article 16 have been fulfilled to the extent required, give written notice of allocation (an "Allocation Notice") to the Seller and each Shareholder to whom Sale Shares have been allocated (an "Applicant") specifying the number of Sale Shares allocated to each Applicant and the place and time (being not less than five Business Days nor more than 10

Business Days after the date of the Allocation Notice) for completion of the transfer of the Sale Shares.

12.8.3 Upon service of an Allocation Notice, the Seller must, against payment of the Transfer Price, transfer the Sale Shares in accordance with the requirements specified in it.

12.8.4 If the Seller fails to comply with the provisions of Article 12.8.3:

12.8.4.1 the chairman of the Company or, failing him, one of the directors, or some other person nominated by a resolution of the Board, may on behalf of the Seller:

12.8.4.1.1 complete, execute and deliver in his name all documents necessary to give effect to the transfer of the relevant Sale Shares to the Applicants;

12.8.4.1.2 receive the Transfer Price and give a good discharge for it; and

12.8.4.1.3 (subject to the transfer being duly stamped) enter the Applicants in the register of Shareholders as the holders of the Shares purchased by them; and

12.8.4.2 the Company shall pay the Transfer Price into a separate bank account in the Company's name on trust (but without interest) or otherwise hold the Transfer Price on trust for the Seller until he has delivered to the Company his certificate or certificates for the relevant Shares (or an indemnity for lost certificate in a form acceptable to the Board).

12.8.5 If an Allocation Notice does not relate to all the Sale Shares then, subject to Article 12.8.6, the Seller may, within eight weeks after service of the Allocation Notice, transfer the unallocated Sale Shares to any person at a price at least equal to the Transfer Price.

12.8.6 The right of the Seller to transfer Shares under Article 12.8.5 does not apply if the Board is of the opinion on reasonable grounds that:

12.8.6.1 the transferee is a person (or a nominee for a person) who the Board (with Founder Director Consent) determine in their absolute discretion is a competitor with (or an Associate of a competitor with) the business of the Company or with a Subsidiary Undertaking of the Company;

12.8.6.2 the sale of the Sale Shares is not bona fide or the price is subject to a deduction, rebate or allowance to the transferee; or

12.8.6.3 the Seller has failed or refused to provide promptly information available to it or him and reasonably requested by the Board for the purpose of enabling it to form the opinion mentioned above.

13 VALUATION OF SHARES

13.1 If no Transfer Price can be agreed between the Seller and the Board in accordance with provisions of Articles 10.9 and 12.2 or otherwise then, on the date of failing agreement, the Board shall either:

13.1.1 appoint an expert valuer in accordance with Article 13.2 (the "Expert Valuer") to certify the Fair Value of the Sale Shares; or

13.1.2 (if the Fair Value has been certified by an Expert Valuer within the preceding 12 weeks) specify that the Fair Value of the Sale Shares will be calculated by dividing any Fair Value so certified by the number of Sale Shares to which it related and multiplying such Fair Value by the number of Sale Shares the subject of the Transfer Notice.

13.2 The Expert Valuer will be either:

13.2.1 the Auditors; or

13.2.2 (if requested by the Seller) an independent firm of Chartered Accountants to be agreed between the Board and the Seller or failing agreement not later than the date 10 Business Days after the date of service of the Transfer Notice to be nominated by the then President of

the Institute of Chartered Accountants in England and Wales on the application of either party and approved by the Company.

- 13.3 The "Fair Value" of the Sale Shares shall be determined by the Expert Valuer on the following assumptions and bases:
- 13.3.1 valuing the Sale Shares as on an arm's-length sale between a willing seller and a willing buyer;
 - 13.3.2 if the Company is then carrying on business as a going concern, on the assumption that it will continue to do so;
 - 13.3.3 that the Sale Shares are capable of being transferred without restriction;
 - 13.3.4 valuing the Sale Shares as a rateable proportion of the total value of all the issued Shares (excluding any Shares held as Treasury Shares) without any premium or discount being attributable to the percentage of the issued share capital of the Company which they represent and taking account of the rights attaching to the Sale Shares; and
 - 13.3.5 reflect any other factors which the Expert Valuer reasonably believes should be taken into account.
- 13.4 If any difficulty arises in applying any of these assumptions or bases then the Expert Valuer shall resolve that difficulty in whatever manner they shall in their absolute discretion think fit.
- 13.5 The Expert Valuer shall be requested to determine the Fair Value within 20 Business Days of their appointment and to notify the Board of their determination.
- 13.6 The Expert Valuer shall act as experts and not as arbitrators and their determination shall be final and binding on the parties (in the absence of fraud or manifest error).
- 13.7 The Board will give the Expert Valuer access to all accounting records or other relevant documents of the Company subject to them agreeing to such confidentiality provisions as the Board may reasonably impose.
- 13.8 The Expert Valuer shall deliver their certificate to the Company. As soon as the Company receives the certificate it shall deliver a copy of it to the Seller. Unless the Sale Shares are to be sold under a Transfer Notice which is deemed to have been served, the Seller may by notice in writing to the Company within five Business Days of the service on him of the copy certificate, cancel the Company's authority to sell the Sale Shares.
- 13.9 The cost of obtaining the certificate shall be paid by the Company unless:
- 13.9.1 the Seller cancels the Company's authority to sell; or
 - 13.9.2 the Sale Price certified by the Expert Valuer is less than the price (if any) offered by the directors to the Seller for the Sale Share before Expert Valuer was instructed,
- in which case the Seller shall bear the cost.

14 COMPULSORY TRANSFERS – GENERAL

- 14.1 A person entitled to a Share in consequence of the bankruptcy of a Shareholder shall be deemed to have given a Transfer Notice in respect of that Share at a time determined by the Directors.
- 14.2 If a Shareholder which is a company, either suffers or resolves for the appointment of a liquidator, administrator or administrative receiver over it or any material part of its assets (other than as part of a bona fide restructuring or reorganisation), the relevant Shareholder (and all its Permitted Transferees) shall be deemed to have given a Transfer Notice in respect of all the shares held by the relevant Shareholder and its Permitted Transferees save to the extent that, and at a time, the Directors may determine.
- 14.3 If there is a change in control (as control is defined in section 1124 of the CTA 2010) of any Shareholder which is a company, it shall be bound at any time, if and when required in writing by the Directors to do so, to give (or procure the giving in the case of a nominee) a Transfer Notice in respect of all the Shares registered in its and their names and their respective nominees' names save that, in the case of the Permitted Transferee, it shall first be permitted to transfer those Shares back to the

Original Shareholder from whom it received its Shares or to any other Permitted Transferee before being required to serve a Transfer Notice. This Article 14.3 shall not apply to the Founder.

15 DEPARTING EMPLOYEES

Deemed Transfer Notice

- 15.1 Subject to Article 15.2, if a holder of Employee Shares ceases to be an Employee, the relevant Employee shall be deemed to have given a Transfer Notice in respect of some or all (such number as determined by the Board with Founder Consent) of their Employee Shares on the Effective Termination Date. For the avoidance of doubt and subject to Article 15.4, the provisions of this Article 15 shall not apply to the Founder or the holders of C Ordinary Shares.
- 15.2 Where an Employee is deemed to have given a Transfer Notice under Article 15.1, if it would be unlawful for the Company to purchase Employee Shares within the Offer Period set out in Article 12.7.1, the Board shall have discretion to cause the deemed Transfer Notice to take effect at any time up to 18 months after the Effective Termination Date PROVIDED THAT the Fair Value of such Employee Shares shall still be calculated as at the Effective Termination Date.
- 15.3 In such circumstances the Transfer Price shall be as follows:
 - 15.3.1 where the relevant Employee ceases to be an Employee by reason of being a Good Leaver, Fair Value of the Employee Shares; and
 - 15.3.2 where the relevant Employee ceases to be an Employee by reason of being a Bad Leaver, the Issue Price of the Employee Shares.
- 15.4 In the event of the death of Ian Finlay all holder(s) of C Ordinary Shares shall be deemed to have given a Transfer Notice in respect of all of their Shares on the date of such death and in such circumstances the C Shareholders shall be treated as Good Leavers and subject to the provisions set out in this Article 15 and references in this Article 15 to "Employee" shall be to the C Shareholders and to "Employee Shares" shall be to the C Ordinary Shares and to "Effective Termination Date" shall be to the date of death.
- 15.5 For the purposes of this Article, Fair Value shall be as agreed between the Board (including Founder Consent) and the relevant Employee, or failing agreement within five Business Days of seeking to agree such price, shall be as determined in accordance with Article 13.
- 15.6 For the purposes of this Article, the Priority Rights shall be such that the Employee Shares are offered in the following order of priority:
 - 15.6.1 to the Company (subject always to the provisions of the Act);
 - 15.6.2 to a Board Invitee; and
 - 15.6.3 to other Shareholders.
- 15.7 All voting rights (and right to receive a notice of and attend all general meetings of the Company) attached to Employee, if any, shall at the time he ceases to be an Employee be suspended unless the Board and the Founder notify him otherwise.

16 CO-SALE RIGHT

- 16.1 No transfer (other than a Permitted Transfer) of any of the Shares may be made or validly registered (whether in one or a series of related transactions) if it is in respect of more than 50% of the Shares (excluding Treasury Shares) unless the relevant Shareholder (a "Co-Sale Shareholder") shall have observed the following procedures of this Article.
- 16.2 After the Co-Sale Shareholder has gone through the pre-emption process set out in Article 11.1, the Co-Sale Shareholder shall give to each other holder of Shares (an "Equity Holder") not less than 15 Business Days' notice in advance of the proposed sale (a "Co-Sale Notice"). The Co-Sale Notice shall specify:
 - 16.2.1 the identity of the proposed purchaser (the "Buyer");
 - 16.2.2 the price per share which the Buyer is proposing to pay;

- 16.2.3 the manner in which the consideration is to be paid;
- 16.2.4 the number of Shares which the Co-Sale Shareholder proposes to sell; and
- 16.2.5 the address where the counter-notice should be sent.

- 16.3 Each Equity Holder shall be entitled within five Business Days after receipt of the Co-Sale Notice, to notify the Co-Sale Shareholder that they wish to sell a certain number of Shares held by them at the proposed sale price, by sending a counter-notice which shall specify the number of Shares which such Equity Holder wishes to sell. The maximum number of shares which an Equity Holder can sell under this procedure shall be:

$$\left(\frac{X}{Y} \right) \times Z$$

where:

- X is the number of Shares held by the Equity Holder;
- Y is the total number of Shares (excluding Treasury Shares) held by the Shareholders;
- Z is the number of Shares the Co-Sale Shareholder proposes to sell.

Any Equity Holder who does not send a counter-notice within such five Business Day period shall be deemed to have specified that they wish to sell no shares.

- 16.4 Following the expiry of five Business Days from the date the Equity Holders receive the Co-Sale Notice, the Co-Sale Shareholder shall be entitled to sell to the Buyer on the terms notified to the Equity Holders (provided that the allocation of the total price paid by the Buyer shall be in accordance with the distribution proceeds set out in Article 5) a number of shares not exceeding the number specified in the Co-Sale Notice less any shares which Equity Holders have indicated they wish to sell, provided that at the same time the Buyer (or another person) purchases from the Equity Holders the number of shares they have respectively indicated they wish to sell on terms no less favourable than those obtained by the Co-Sale Shareholder from the Buyer.
- 16.5 No sale by the Co-Sale Shareholder shall be made pursuant to any Co-Sale Notice more than three months after service of that Co-Sale Notice.
- 16.6 Sales made in accordance with this Article 16 shall not be subject to Article 11.1.

17 DRAG-ALONG

- 17.1 Subject to Article 17.1, if the holders of over 75% of the aggregate of the Ordinary Shares (which must include the Founder) (the "Selling Shareholders") wish to transfer all their interest in Shares (the "Sellers' Shares") to a Proposed Purchaser, the Selling Shareholders shall have the option (the "Drag Along Option") to compel each other holder of Shares (each a "Called Shareholder" and together the "Called Shareholders") to sell and transfer all their Shares to the Proposed Purchaser or as the Proposed Purchaser shall direct (the "Drag Purchaser") in accordance with the provisions of this Article.
- 17.2 Notwithstanding the provisions of Article 17.1, the Selling Shareholders shall not be able to compel the holders of C Ordinary Shares to sell and transfer their Shares to a Proposed Purchaser within 4 years of the Date of Adoption if the total consideration proposed to be paid by the Drag Purchaser for all of the Shares in the Company would be less than the aggregate of (a) £1,500,000 (one million five hundred thousand pounds).
- 17.3 The Selling Shareholders may exercise the Drag Along Option by giving a written notice to that effect (a "Drag Along Notice") to the Company which the Company shall forthwith copy to the Called Shareholders at any time before the transfer of the Sellers' Shares to the Drag Purchaser. A Drag Along Notice shall specify that:
- 17.3.1 the Called Shareholders are required to transfer all their Shares (the "Called Shares") under this Article;
 - 17.3.2 the person to whom they are to be transferred;

- 17.3.3 the consideration for which the Called Shares are to be transferred (calculated in accordance with this Article);
- 17.3.4 the proposed date of transfer, and
- 17.3.5 the form of any sale agreement or form of acceptance or any other document of similar effect that the Called Shareholders are required to sign in connection with such sale (the "Sale Agreement"),

(and, in the case of paragraphs 17.3.2 to 17.3.4 above, whether actually specified or to be determined in accordance with a mechanism described in the Drag Along Notice). No Drag Along Notice or Sale Agreement may require a Called Shareholder to agree to any terms except those specifically provided for in this Article.

- 17.4 Drag Along Notices shall be irrevocable but will lapse if for any reason there is not a sale of the Sellers' Shares by the Selling Shareholders to the Drag Purchaser within 60 Business Days after the date of service of the Drag Along Notice. The Selling Shareholders shall be entitled to serve further Drag Along Notices following the lapse of any particular Drag Along Notice.
- 17.5 The consideration (in cash or otherwise) for which the Called Shareholders shall be obliged to sell each of the Called Shares shall be that to which they would be entitled if the total consideration proposed to be paid by the Drag Purchaser were distributed to the holders of the Called Shares and the Sellers' Shares in accordance with the provisions of Article 5 (the "Drag Consideration").
- 17.6 In respect of a transaction that is the subject of a Drag-Along Notice and with respect to any Drag Document, a Called Shareholder shall only be obliged to undertake to transfer his Shares with full title guarantee (and provide an indemnity for lost certificate in a form acceptable to the Board if so necessary) in receipt of the Drag Consideration when due and shall not be obliged to give warranties or indemnities except a warranty as to capacity to enter into a Drag Document and the full title guarantee of the Shares held by such Called Shareholder.
- 17.7 Within three Business Days of the Company copying the Drag Along Notice to the Called Shareholders (or such later date as may be specified in the Drag Along Notice) (the "Drag Completion Date"), each Called Shareholder shall deliver:
 - 17.7.1 duly executed stock transfer form(s) for its Shares in favour of the Drag Purchaser;
 - 17.7.2 the relevant share certificate(s) (or a duly executed indemnity for lost certificate in a form acceptable to the Board) to the Company; and
 - 17.7.3 duly executed Sale Agreement, if applicable, in the form specified in the Drag Along Notice or as otherwise specified by the Company,(together the "Drag Documents").
- 17.8 On the Drag Completion Date, the Company shall pay each Called Shareholder, on behalf of the Drag Purchaser, the Drag Consideration that is due to the extent the Drag Purchaser has paid such consideration to the Company. The Company's receipt of the Drag Consideration shall be a good discharge to the Drag Purchaser. The Company shall hold the Drag Consideration in trust for each of the Called Shareholders without any obligation to pay interest.
- 17.9 To the extent that the Drag Purchaser has not, on the Drag Completion Date, paid the Drag Consideration that is due to the Company, the Called Shareholders shall be entitled to the immediate return of the Drag Documents for the relevant Shares and the Called Shareholders shall have no further rights or obligations under this Article 17 in respect of their Shares.
- 17.10 If a Called Shareholder fails to deliver the Drag Documents for its Shares to the Company by the Drag Completion Date, the Company and each Director shall be constituted the agent of such defaulting Called Shareholder to take such actions and enter into any Drag Document or such other agreements or documents as are necessary to effect the transfer of the Called Shareholder's Shares pursuant to this Article 17 and the Directors shall, if requested by the Drag Purchaser, authorise any Director to transfer the Called Shareholder's Shares on the Called Shareholder's behalf to the Drag Purchaser to the extent the Drag Purchaser has, by the Drag Completion Date, paid the Drag Consideration to the Company for the Called Shareholder's Shares offered to him. The Board shall then authorise

registration of the transfer once appropriate stamp duty has been paid. The defaulting Called Shareholder shall surrender his share certificate for his Shares (or suitable executed indemnity) to the Company. On surrender, he shall be entitled to the Drag Consideration due to him.

- 17.11 Any transfer of Shares to a Drag Purchaser pursuant to a sale in respect of which a Drag Along Notice has been duly served shall not be subject to the provisions of Article 11.1.
- 17.12 On any person, following the issue of a Drag Along Notice, becoming a Shareholder pursuant to the exercise of a pre-existing option or warrant to acquire shares in the Company or pursuant to the conversion of any convertible security of the Company (a "New Shareholder"), a Drag Along Notice shall be deemed to have been served on the New Shareholder on the same terms as the previous Drag Along Notice who shall then be bound to sell and transfer all Shares so acquired to the Drag Purchaser and the provisions of this Article shall apply with the necessary changes to the New Shareholder except that completion of the sale of the Shares shall take place immediately on the Drag Along Notice being deemed served on the New Shareholder.
- 17.13 In the event that an Asset Sale is approved by the Board (with Founder Consent) and the holders of over 75% of the aggregate of the Ordinary Shares (which must include the Founder), such Shareholders shall have the right, by notice in writing to all other Shareholders, to require such Shareholders to take any and all such actions as it may be necessary for Shareholders to take in order to give effect to or otherwise implement such Asset Sale, subject always to the proceeds from such Asset Sale being distributed to Shareholders in accordance with the provisions of Articles 5 and 6.

18 GENERAL MEETINGS

- 18.1 If the Directors are required by the Shareholders under section 303 of the Act to call a general meeting, the Directors shall convene the meeting for a date not later than 28 days after the date on which the Directors became subject to the requirement under section 303 of the Act.
- 18.2 If any two or more Shareholders attend the meeting in different locations, the meeting shall be treated as being held at the location specified in the notice of the meeting, save that if no one is present at that location so specified, the meeting shall be deemed to take place where the largest number of Qualifying Persons is assembled or, if no such group can be identified, at the location of the chairman.
- 18.3 If a demand for a poll is withdrawn under article 44(3) of the Model Articles, the demand shall not be taken to have invalidated the result of a show of hands declared before the demand was made and the meeting shall continue as if the demand had not been made.
- 18.4 Polls must be taken in such manner as the chairman directs. A poll demanded on the election of a chairman or on a question of adjournment must be held immediately. A poll demanded on any other question must be held either immediately or at such time and place as the chairman directs not being more than 14 days after the poll is demanded. The demand for a poll shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll was demanded.
- 18.5 No notice need be given of a poll not held immediately if the time and place at which it is to be taken are announced at the meeting at which it is demanded. In any other case at least seven clear days' notice shall be given specifying the time and place at which the poll is to be taken.
- 18.6 If the poll is to be held more than 48 hours after it was demanded the Shareholders shall be entitled to deliver Proxy Notices in respect of the poll at any time up to 24 hours before the time appointed for taking that poll. In calculating that period, no account shall be taken of any part of a day that is not a working day.

19 PROXIES

- 19.1 Paragraph (c) of article 45(1) of the Model Articles shall be deleted and replaced by the words: "is signed by or on behalf of the shareholder appointing the proxy and accompanied by any the authority under which it is signed (or a certified copy of such authority or a copy of such authority in some other way approved by the directors)".
- 19.2 The instrument appointing a proxy and any authority under which it is signed or a certified copy of such authority or a copy in some other way approved by the Directors may:

- 19.2.1 be sent or supplied in hard copy form, or (subject to any conditions and limitations which the Board may specify) in electronic form, to the registered office of the Company or to such other address (including electronic address) as may be specified for this purpose in the notice convening the meeting or in any instrument of proxy or any invitation to appoint a proxy sent or supplied by the Company in relation to the meeting at any time before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote;
 - 19.2.2 be delivered at the meeting or adjourned meeting at which the person named in the instrument proposes to vote to the chairman or to the company secretary or to any Director; or
 - 19.2.3 in the case of a poll, be delivered at the meeting at which the poll was demanded to the chairman or to the company secretary or to any Director, or at the time and place at which the poll is held to the chairman or to the company secretary or to any Director or scrutineer,
- and an instrument of proxy which is not deposited or delivered in a manner so permitted shall be invalid.

20 DIRECTORS' BORROWING POWERS

The Directors may, with Founder Director Consent or Founder Consent where required, exercise all the powers of the Company to borrow or raise money and to mortgage or charge its undertaking, property and uncalled capital and to issue debentures, debenture stock and other securities as security for any debt, liability of obligation of the Company or of any third party.

21 ALTERNATE DIRECTORS

- 21.1 Notwithstanding any provision of these Articles to the contrary, any person appointed as a Director (the "Appointor") may appoint any director or any other person as he thinks fit to be his alternate Director to:
 - 21.1.1 exercise that Director's powers; and
 - 21.1.2 carry out that Director's responsibilities in relation to the taking of decisions by the Directors in the absence of the alternate's Appointor.
- The appointment of an alternate Director shall not require approval by a resolution of the Directors.
- 21.2 Any appointment or removal of an alternate must be effected by notice in writing to the Company signed by the Appointor, or in any other manner approved by the Directors.
 - 21.3 The notice must:
 - 21.3.1 identify the proposed alternate; and
 - 21.3.2 in the case of a notice of appointment, contain a statement signed by the proposed alternate that the proposed alternate is willing to act as the alternate of the Director giving the notice.
 - 21.4 An alternate Director may act as an alternate to more than one Director and has the same rights, in relation to any Directors' meeting (including as to notice) or Directors' written resolution, as the alternate's Appointor.
 - 21.5 Except as these Articles specify otherwise, alternate directors:
 - 21.5.1 are deemed for all purposes to be Directors;
 - 21.5.2 are liable for their own acts and omissions;
 - 21.5.3 are subject to the same restrictions as their Appointors; and
 - 21.5.4 are not deemed to be agents of or for their Appointors,and, in particular (without limitation), each alternate director shall be entitled to receive notice of all meetings of Directors and of all meetings of committees of Directors of which his Appointor is a member.
 - 21.6 A person who is an alternate Director but not a Director:

21.6.1 may be counted as participating for the purposes of determining whether a quorum is participating (but only if that person's Appointor is not participating); and

21.6.2 may sign a Directors' written resolution (but only if his Appointor is an Eligible Director in relation to that decision, but does not participate).

No alternate may be counted as more than one Director for such purposes.

21.7 A Director who is also an alternate Director is entitled, in the absence of his Appointor, to a separate vote on behalf of each Appointor, in addition to his own vote on any decision of the Directors (provided that his Appointor is an Eligible Director in relation to that decision).

21.8 An alternate Director is not entitled to receive any remuneration from the company for serving as an alternate Director, except such part of the alternate's Appointor's remuneration as the Appointor may direct by notice in writing made to the Company.

21.9 An alternate Director's appointment as an alternate shall terminate:

21.9.1 when the alternate's Appointor revokes the appointment by notice to the Company in writing specifying when it is to terminate;

21.9.2 on the occurrence in relation to the alternate of any event which, if it occurred in relation to the alternate's Appointor, would result in the termination of the Appointor's appointment as a Director;

21.9.3 on the death of the alternate's Appointor; or

21.9.4 when the alternate's Appointor's appointment as a Director terminates.

22 NUMBER OF DIRECTORS

Unless and until the Company shall otherwise determine by ordinary resolution, the number of Directors shall be not less than two and no more than four.

23 APPOINTMENT OF DIRECTORS

23.1 In addition to the powers of appointment under article 17(1) of the Model Articles, for such time as the Founder is a Shareholder, the Founder shall be entitled to nominate one person to act as the Founder Director by notice in writing addressed to the Company from time to time and the other holders of Shares shall not vote their Shares so as to remove such Director from office. The Founder shall be entitled to remove their nominated Director so appointed at any time by notice in writing to the Company served at its registered office and appoint another person to act in his place.

23.2 In addition to the powers of appointment under article 17(1) of the Model Articles, for such time as the holders of C Ordinary Shares at the Date of Adoption are both a Shareholder, they shall be entitled to jointly nominate one person to act as a non-executive Director by notice in writing addressed to the Company from time to time and the other holders of Shares shall not vote their Shares so as to remove such Director from office. The holders of C Ordinary Shares shall be entitled to remove their nominated non-executive Director so appointed at any time by notice in writing to the Company served at its registered office and appoint another person to act in his place.

23.3 An appointment or removal of a Director under Articles 23.1 and 23.2 will take effect at and from the time when the notice is received at the registered office of the Company or produced to a meeting of the directors of the Company.

23.4 The Founder Director shall be entitled at his request to be appointed to any committee of the Board established from time to time and to the board of directors of any Subsidiary Undertaking.

24 DISQUALIFICATION OF DIRECTORS

24.1 In addition to that provided in article 18 of the Model Articles, the office of a Director shall also be vacated if:

24.1.1 he is convicted of a criminal offence (other than a minor motoring offence) and the Directors resolve that his office be vacated; or

- 24.1.2 in the case of Directors other than the Founder Director or a Director appointed under Article 23.2, if a majority of his co-Directors (including Founder Director Consent) serve notice on him in writing, removing him from office; or
- 24.1.3 in the case of Directors other than a Founder Director or a Director appointed under Article 23.2, if a majority of holders of Shares serve notice on him in writing, removing him from office.

25 PROCEEDINGS OF DIRECTORS

- 25.1 The quorum for Directors' meetings shall be three Directors who must include the Founder Director unless there is no Founder Director in office or unless the Founder Director has confirmed in writing before any meeting that he waives his right to attend such meeting (save that where a Relevant Interest of the Founder Director is being authorised by other Directors in accordance with section 175(5)(a) of the Act, such Founder Director and any other interested Director shall not be included in the quorum required for the purpose of such authorisation but shall otherwise be included for the purpose of forming the quorum at the meeting). If such a quorum is not present within half an hour from the time appointed for the meeting, or if during a meeting such quorum ceases to be present, the meeting shall stand adjourned to the same day in the next week at the same time and place or at such time and place as determined by the Directors present at such meeting and the Founder Director. If a quorum is not present at any such adjourned meeting within half an hour from the time appointed, then the meeting shall proceed.
- 25.2 In the event that a meeting of the Directors is attended by a Director who is acting as alternate for one or more other Directors, the Director or Directors for whom he is the alternate shall be counted in the quorum despite their absence, and if on that basis there is a quorum the meeting may be held despite the fact (if it is the case) that only one Director is physically present.
- 25.3 If all the Directors participating in a meeting of the Directors are not physically in the same place, the meeting shall be deemed to take place where the largest group of participators in number is assembled. In the absence of a majority the location of the chairman shall be deemed to be the place of the meeting.
- 25.4 Notice of a Directors' meeting need not be given to Directors who waive their entitlement to notice of that meeting, by giving notice to that effect to the Company at any time before or after the date on which the meeting is held. Where such notice is given after the meeting has been held, that does not affect the validity of the meeting, or of any business conducted at it.
- 25.5 Subject to Article 27.6 Provided (if these Articles so require) that he has declared to the Directors, in accordance with the provisions of these Articles, the nature and extent of his interest (and subject to any restrictions on voting or counting in a quorum imposed by the Directors in authorising a Relevant Interest), a Director may vote at a meeting of the Directors or of a committee of the Directors on any resolution concerning a matter in which he has an interest, whether a direct or an indirect interest, or in relation to which he has a duty and shall also be counted in reckoning whether a quorum is present at such a meeting.
- 25.6 Questions arising at any meeting of the Directors shall be decided by a majority of votes. In the case of any equality of votes, the chairman shall have a second or casting vote.
- 25.7 A decision of the Directors may take the form of a resolution in writing, where each Eligible Director has signed one or more copies of it, or to which each Eligible Director has otherwise indicated agreement in writing (including confirmation given by electronic means). Reference in article 7(1) of the Model Articles to article 8 of the Model Articles shall be deemed to include a reference to this article also.

26 DIRECTORS' INTERESTS

Specific interests of a Director

- 26.1 Subject to the provisions of the Act and provided (if these Articles so require) that he has declared to the Directors in accordance with the provisions of these Articles, the nature and extent of his interest, a Director may (save as to the extent not permitted by law from time to time), notwithstanding his office, have an interest of the following kind:

- 26.1.1 where a Director (or a person connected with him) is party to or in any way directly or indirectly interested in, or has any duty in respect of, any existing or proposed contract, arrangement or transaction with the Company or any other undertaking in which the Company is in any way interested;
- 26.1.2 where a Director (or a person connected with him) is a director, employee or other officer of, or a party to any contract, arrangement or transaction with, or in any way interested in, any body corporate promoted by the Company or in which the Company is in any way interested;
- 26.1.3 where a Director (or a person connected with him) is a shareholder in the Company or a shareholder in, employee, director, member or other officer of, or consultant to, a Parent Undertaking of, or a Subsidiary Undertaking of a Parent Undertaking of, the Company;
- 26.1.4 where a Director (or a person connected with him) holds and is remunerated in respect of any office or place of profit (other than the office of auditor) in respect of the Company or body corporate in which the Company is in any way interested;
- 26.1.5 where a Director is given a guarantee, or is to be given a guarantee, in respect of an obligation incurred by or on behalf of the Company or any body corporate in which the Company is in any way interested;
- 26.1.6 where a Director (or a person connected with him or of which he is a member or employee) acts (or any body corporate promoted by the Company or in which the Company is in any way interested of which he is a director, employee or other officer may act) in a professional capacity for the Company or any body corporate promoted by the Company or in which the Company is in any way interested (other than as auditor) whether or not he or it is remunerated for this;
- 26.1.7 an interest which cannot reasonably be regarded as likely to give rise to a conflict of interest; or
- 26.1.8 any other interest authorised by ordinary resolution.

Interests of which a Director is not aware

- 26.2 For the purposes of this Article 26, an interest of which a Director is not aware and of which it is unreasonable to expect him to be aware shall not be treated as an interest of his.

Accountability of any benefit and validity of a contract

- 26.3 In any situation permitted by this Article 26 (save as otherwise agreed by him) a Director shall not by reason of his office be accountable to the Company for any benefit which he derives from that situation and no such contract, arrangement or transaction shall be avoided on the grounds of any such interest or benefit.

Terms and conditions of Board authorisation

- 26.4 Subject to Article 26.5, any authority given in accordance with section 175(5)(a) of the Act in respect of a Director ("Interested Director") who has proposed that the Directors authorise his interest ("Relevant Interest") pursuant to that section may, for the avoidance of doubt:
 - 26.4.1 be given on such terms and subject to such conditions or limitations as may be imposed by the authorising Directors as they see fit from time to time, including, without limitation:
 - 26.4.1.1 restricting the Interested Director from voting on any resolution put to a meeting of the Directors or of a committee of the Directors in relation to the Relevant Interest;
 - 26.4.1.2 restricting the Interested Director from being counted in the quorum at a meeting of the Directors or of a committee of the Directors where such Relevant Interest is to be discussed; or
 - 26.4.1.3 restricting the application of the provisions in Articles 26.6 and 26.7, so far as is permitted by law, in respect of such Interested Director;

26.4.2 be withdrawn, or varied at any time by the Directors entitled to authorise the Relevant Interest as they see fit from time to time; and

subject to Article 26.5, an Interested Director must act in accordance with any such terms, conditions or limitations imposed by the authorising Directors pursuant to section 175(5)(a) of the Act and this Article 26.

Terms and conditions of Board authorisation for the Founder Director

26.5 Notwithstanding the other provisions of this Article 26, it shall not (save with the consent in writing of the Founder Director) be made a condition of any authorisation of a matter in relation to that Founder Director in accordance with section 175(5)(a) of the Act, that he shall be restricted from voting or counting in the quorum at any meeting of, or of any committee of the Directors or that he shall be required to disclose, use or apply confidential information as contemplated in Article 26.7.

Director's duty of confidentiality to a person other than the Company

26.6 Subject to Article 26.7 (and without prejudice to any equitable principle or rule of law which may excuse or release the Director from disclosing information, in circumstances where disclosure may otherwise be required under this Article 26), if a Director, otherwise than by virtue of his position as director, receives information in respect of which he owes a duty of confidentiality to a person other than the Company, he shall not be required:

26.6.1 to disclose such information to the Company or to any Director, or to any officer or employee of the Company; or

26.6.2 otherwise to use or apply such confidential information for the purpose of or in connection with the performance of his duties as a Director.

26.7 Where such duty of confidentiality arises out of a situation in which a Director has, or can have, a direct or indirect interest that conflicts, or possibly may conflict, with the interests of the Company, Article 26.6 shall apply only if the conflict arises out of a matter which falls within Article 26.1 or has been authorised under section 175(5)(a) of the Act.

Additional steps to be taken by a Director to manage a conflict of interest

26.8 Where a Director has an interest which can reasonably be regarded as likely to give rise to a conflict of interest, the Director shall take such additional steps as may be necessary or desirable for the purpose of managing such conflict of interest, including compliance with any procedures laid down from time to time by the Directors for the purpose of managing conflicts of interest generally and/or any specific procedures approved by the Directors for the purpose of or in connection with the situation or matter in question, including without limitation:

26.8.1 absenting himself from any discussions, whether in meetings of the Directors or otherwise, at which the relevant situation or matter falls to be considered; and

26.8.2 excluding himself from documents or information made available to the Directors generally in relation to such situation or matter and/or arranging for such documents or information to be reviewed by a professional adviser to ascertain the extent to which it might be appropriate for him to have access to such documents or information.

Requirement of a Director to declare an interest

26.9 Subject to section 182 of the Act, a Director shall declare the nature and extent of any interest permitted by Article 26.1 at a meeting of the Directors, or by general notice in accordance with section 184 (notice in writing) or section 185 (general notice) of the Act or in such other manner as the Directors may determine, except that no declaration of interest shall be required by a Director in relation to an interest:

26.9.1 falling under Article 26.1.7;

26.9.2 if, or to the extent that, the other Directors are already aware of such interest (and for this purpose the other Directors are treated as aware of anything of which they ought reasonably to be aware); or

- 26.9.3 if, or to the extent that, it concerns the terms of his service contract (as defined by section 227 of the Act) that have been or are to be considered by a meeting of the Directors, or by a committee of Directors appointed for the purpose under these Articles.

Shareholder approval

- 26.10 Subject to section 239 of the Act, the Company may by ordinary resolution ratify any contract, transaction or arrangement, or other proposal, not properly authorised by reason of a contravention of any provisions of this Article 26.
- 26.11 For the purposes of this Article 26:
- 26.11.1 a conflict of interest includes a conflict of interest and duty and a conflict of duties;
- 26.11.2 the provisions of section 252 of the Act shall determine whether a person is connected with a Director;
- 26.11.3 a general notice to the Directors that a Director is to be regarded as having an interest of the nature and extent specified in the notice in any transaction or arrangement in which a specified person or class of persons is interested shall be deemed to be a disclosure that the Director has an interest in any such transaction of the nature and extent so specified.

27 NOTICES

- 27.1 Subject to the requirements set out in the Act, any notice given or document sent or supplied to or by any person under these Articles, or otherwise sent by the Company under the Act, may be given, sent or supplied:
- 27.1.1 in hard copy form;
- 27.1.2 in electronic form; or
- 27.1.3 (by the Company) by means of a website (other than notices calling a meeting of Directors), or partly by one of these means and partly by another of these means.
- Notices shall be given and documents supplied in accordance with the procedures set out in the Act, except to the extent that a contrary provision is set out in this Article 27.

Notices in hard copy form

- 27.2 Any notice or other document in hard copy form given or supplied under these Articles may be delivered or sent by first class post (airmail if overseas):
- 27.2.1 to the Company or any other company at its registered office; or
- 27.2.2 to the address notified to or by the Company for that purpose; or
- 27.2.3 in the case of an intended recipient who is a member or his legal personal representative or trustee in bankruptcy, to such member's address as shown in the Company's register of members; or
- 27.2.4 in the case of an intended recipient who is a Director or alternate, to his address as shown in the register of Directors; or
- 27.2.5 to any other address to which any provision of the Companies Acts (as defined in the Act) authorises the document or information to be sent or supplied; or
- 27.2.6 where the Company is the sender, if the Company is unable to obtain an address falling within one of the addresses referred to in (a) to (e) above, to the intended recipient's last address known to the Company.
- 27.3 Any notice or other document in hard copy form given or supplied under these Articles shall be deemed to have been served and be effective:
- 27.3.1 if delivered, at the time of delivery;
- 27.3.2 if posted, on receipt or 48 hours after the time it was posted, whichever occurs first.

Notices in electronic form

- 27.4 Subject to the provisions of the Act, any notice or other document in electronic form given or supplied under these Articles may:
- 27.4.1 if sent by fax or email (provided that a fax number or an address for email has been notified to or by the Company for that purpose), be sent by the relevant form of communication to that address;
 - 27.4.2 if delivered or sent by first class post (airmail if overseas) in an electronic form (such as sending a disk by post), be so delivered or sent as if in hard copy form under Article 27.2; or
 - 27.4.3 be sent by such other electronic means (as defined in section 1168 of the Act) and to such address(es) as the Company may specify:
 - 27.4.3.1 on its website from time to time; or
 - 27.4.3.2 by notice (in hard copy or electronic form) to all members of the Company from time to time.
- 27.5 Any notice or other document in electronic form given or supplied under these Articles shall be deemed to have been served and be effective:
- 27.5.1 if sent by fax or email (where a fax number or an address for email has been notified to or by the Company for that purpose), on receipt or 48 hours after the time it was sent, whichever occurs first;
 - 27.5.2 if posted in an electronic form, on receipt or 48 hours after the time it was posted, whichever occurs first;
 - 27.5.3 if delivered in an electronic form, at the time of delivery; and
 - 27.5.4 if sent by any other electronic means as referred to in Article 27.4.3, at the time such delivery is deemed to occur under the Act.
- 27.6 Where the Company is able to show that any notice or other document given or sent under these Articles by electronic means was properly addressed with the electronic address supplied by the intended recipient, the giving or sending of that notice or other document shall be effective notwithstanding any receipt by the Company at any time of notice either that such method of communication has failed or of the intended recipient's non-receipt.

Notice by means of a website

- 27.7 Subject to the provisions of the Act, any notice or other document or information to be given, sent or supplied by the Company to Shareholders under these Articles may be given, sent or supplied by the Company by making it available on the Company's website.

General

- 27.8 In the case of joint holders of a share all notices shall be given to the joint holder whose name stands first in the register of members of the Company in respect of the joint holding (the "Primary Holder"). Notice so given shall constitute notice to all the joint holders.
- 27.9 Anything agreed or specified by the Primary Holder in relation to the service, sending or supply of notices, documents or other information shall be treated as the agreement or specification of all the joint holders in their capacity as such (whether for the purposes of the Act or otherwise).

28 INDEMNITIES AND INSURANCE

- 28.1 Subject to the provisions of and so far as may be permitted by, the Act:
- 28.1.1 every Director or other officer of the Company (excluding the Company's auditors) shall be entitled to be indemnified by the Company (and the Company shall also be able to indemnify directors of any associated company (as defined in section 256 of the Act)) out of the Company's assets against all liabilities incurred by him in the actual or purported execution or discharge of his duties or the exercise or purported exercise of his powers or otherwise in

relation to or in connection with his duties, powers or office, provided that no Director or any associated company is indemnified by the Company against:

28.1.1.1 any liability incurred by the director to the Company or any associated company; or

28.1.1.2 any liability incurred by the director to pay a fine imposed in criminal proceedings or a sum payable to a regulatory authority by way of a penalty in respect of non-compliance with any requirements of a regulatory nature; or

28.1.1.3 any liability incurred by the director:

28.1.1.3.1 in defending any criminal proceedings in which he is convicted;

28.1.1.3.2 in defending civil proceedings brought by the Company or any associated company in which final judgment (within the meaning set out in section 234 of the Act) is given against him; or

28.1.1.3.3 in connection with any application under sections 661(3) or 661(4) or 1157 of the Act (as the case may be) for which the court refuses to grant him relief,

save that, in respect of a provision indemnifying a director of a company (whether or not the Company) that is a trustee of an occupational pension scheme (as that term is used in section 235 of the Act) against liability incurred in connection with that company's activities as trustee of the scheme, the Company shall also be able to indemnify any such director without the restrictions in Articles 28.1.1.1, 28.1.1.3.2 and 28.1.1.3.3 applying;

28.1.2 the Directors may exercise all the powers of the Company to purchase and maintain insurance for any such Director or other officer against any liability which by virtue of any rule of law would otherwise attach to him in respect of any negligence, default, breach of duty or breach of trust of which he may be guilty in relation to the Company, or any associated company including (if he is a director of a company which is a trustee of an occupational pension scheme) in connection with that company's activities as trustee of an occupational pension scheme.

28.2 The Company shall (at the cost of the Company) effect and maintain for each Director policies of insurance insuring each Director against risks in relation to his office as each director may reasonably specify including without limitation, any liability which by virtue of any rule of law may attach to him in respect of any negligence, default of duty or breach of trust of which he may be guilty in relation to the Company.

29 DATA PROTECTION

Each of the Shareholders and Directors consent to the processing of their personal data by the Company, the Shareholders and Directors (each a "Recipient") for the purpose of due diligence exercises, compliance with applicable laws, regulations and procedures and the exchange of information among themselves. A Recipient may process the personal data either electronically or manually. The personal data which may be processed under this Article shall include any information which may have a bearing on the prudence or commercial merits of investing, or disposing of any shares (or other investment or security) in the Company. Other than as required by law, court order or other regulatory authority, that personal data may not be disclosed by a Recipient or any other person except to a Member of the same Group ("Recipient Group Companies") and to employees, directors and professional advisers of that Recipient or the Recipient Group Companies and funds managed by any of the Recipient Group Companies. Each of the Shareholders and Directors consent to the transfer of relevant personal data to persons acting on behalf of the Recipient and to the offices of any Recipient both within and outside the European Economic Area for the purposes stated above, where it is necessary or desirable to do so.

30 SECRETARY

Subject to the provisions of the Act, the Directors may appoint a secretary for such term, at such remuneration and upon such conditions as they may think fit; and any secretary so appointed may be removed by them.

31 LIEN

31.1 The Company shall have a first and paramount lien (the "Company's Lien") over every Share (not being a fully paid share) for all moneys (whether presently payable or not) payable at a fixed time or called in respect of that Share.

31.2 The Company's Lien over a Share:

31.2.1 shall take priority over any third party's interest in that Share; and

31.2.2 extends to any dividend or other money payable by the Company in respect of that Share and (if the lien is enforced and the Share is sold by the Company) the proceeds of sale of that Share.

The Directors may at any time decide that a Share which is, or would otherwise be, subject to the Company's Lien shall not be subject to it, either wholly or in part.

31.3 Subject to the provisions of this Article 31, if:

31.3.1 a notice complying with Article 31.4 (a "Lien Enforcement Notice") has been given by the Company in respect of a Share; and

31.3.2 the person to whom the notice was given has failed to comply with it,
the Company shall be entitled to sell that Share in such manner as the Directors decide.

31.4 A Lien Enforcement Notice:

31.4.1 may only be given by the Company in respect of a Share which is subject to the Company's Lien, in respect of which a sum is payable and the due date for payment of that sum has passed;

31.4.2 must specify the Share concerned;

31.4.3 must require payment of the sum payable within 14 days of the notice;

31.4.4 must be addressed either to the holder of the Share or to a person entitled to it by reason of the holder's death, bankruptcy or otherwise; and

31.4.5 must state the Company's intention to sell the Share if the notice is not complied with.

31.5 Where any Share is sold pursuant to this Article 31:

31.5.1 the Directors may authorise any person to execute an instrument of transfer of the Share to the purchaser or a person nominated by the purchaser; and

31.5.2 the transferee shall not be bound to see to the application of the consideration, and the transferee's title shall not be affected by any irregularity in or invalidity of the process leading to the sale.

31.6 The net proceeds of any such sale (after payment of the costs of sale and any other costs of enforcing the lien) must be applied:

31.6.1 first, in payment of so much of the sum for which the lien exists as was payable at the date of the Lien Enforcement Notice;

31.6.2 secondly, to the person entitled to the Share at the date of the sale, but only after the certificate for the Share sold has been surrendered to the Company for cancellation or an indemnity for lost certificate in a form acceptable to the Board has been given for any lost certificate, and subject to a lien equivalent to the Company's Lien for any money payable (whether or not it is presently payable) as existing upon the Share before the sale in respect of all Shares registered in the name of that person (whether as the sole registered holder or as one of several joint holders) after the date of the Lien Enforcement Notice.

31.7 A statutory declaration by a Director or the company secretary that the declarant is a Director or the company secretary and that a Share has been sold to satisfy the Company's Lien on a specified date:

31.7.1 shall be conclusive evidence of the facts stated in it as against all persons claiming to be entitled to the Share; and

31.7.2 subject to compliance with any other formalities of transfer required by these Articles or by law, shall constitute a good title to the Share.

32 CALL NOTICES

32.1 Subject to these Articles and the terms on which Shares are allotted, the Directors may send a notice (a "Call Notice") to a Shareholder who has not fully paid for that Shareholder's Share(s) requiring the Shareholder to pay the Company a specified sum of money (a "call") which is payable to the Company by that Shareholder when the Directors decide to send the Call Notice.

32.2 A Call Notice:

32.2.1 may not require a Shareholder to pay a call which exceeds the total sum unpaid on that Shareholder's Shares (whether as to the Share's nominal value or any sum payable to the Company by way of premium);

32.2.2 shall state when and how any call to which it relates it is to be paid; and

32.2.3 may permit or require the call to be paid by instalments.

32.3 A Shareholder shall comply with the requirements of a Call Notice, but no Shareholder shall be obliged to pay any call before 14 days have passed since the notice was sent.

32.4 Before the Company has received any call due under a Call Notice the Directors may:

32.4.1 revoke it wholly or in part; or

32.4.2 specify a later time for payment than is specified in the Call Notice, by a further notice in writing to the Shareholder in respect of whose Shares the call is made.

32.5 Liability to pay a call shall not be extinguished or transferred by transferring the Shares in respect of which it is required to be paid. Joint holders of a Share shall be jointly and severally liable to pay all calls in respect of that Share.

32.6 Subject to the terms on which Shares are allotted, the Directors may, when issuing Shares, provide that Call Notices sent to the holders of those Shares may require them to:

32.6.1 pay calls which are not the same; or

32.6.2 pay calls at different times.

32.7 A Call Notice need not be issued in respect of sums which are specified, in the terms on which a Share is issued, as being payable to the Company in respect of that Share (whether in respect of nominal value or premium):

32.7.1 on allotment;

32.7.2 on the occurrence of a particular event; or

32.7.3 on a date fixed by or in accordance with the terms of issue.

32.8 If the due date for payment of such a sum as referred to in Article 32.7 has passed and it has not been paid, the holder of the Share concerned shall be treated in all respects as having failed to comply with a Call Notice in respect of that sum, and shall be liable to the same consequences as regards the payment of interest and forfeiture.

32.9 If a person is liable to pay a call and fails to do so by the Call Payment Date (as defined below):

32.9.1 the Directors may issue a notice of intended forfeiture to that person; and

32.9.2 until the call is paid, that person shall be required to pay the Company interest on the call from the Call Payment Date at the Relevant Rate (as defined below).

32.10 For the purposes of Article 32.9:

32.10.1 the "Call Payment Date" shall be the time when the call notice states that a call is payable, unless the Directors give a notice specifying a later date, in which case the "Call Payment Date" is that later date;

32.10.2 the "Relevant Rate" shall be:

32.10.2.1 the rate fixed by the terms on which the Share in respect of which the call is due was allotted;

32.10.2.2 such other rate as was fixed in the Call Notice which required payment of the call, or has otherwise been determined by the Directors; or

32.10.2.3 if no rate is fixed in either of these ways, 5% a year, provided that the Relevant Rate shall not exceed by more than five percentage points the base lending rate most recently set by the Monetary Policy Committee of the Bank of England in connection with its responsibilities under Part 2 of the Bank of England Act 1998(a).

32.11 The Directors may waive any obligation to pay interest on a call wholly or in part.

32.12 The Directors may accept full payment of any unpaid sum in respect of a Share despite payment not being called under a Call Notice.

33 FORFEITURE OF SHARES

33.1 A notice of intended forfeiture:

33.1.1 may be sent in respect of any Share for which there is an unpaid sum in respect of which a call has not been paid as required by a Call Notice;

33.1.2 shall be sent to the holder of that Share or to a person entitled to it by reason of the holder's death, bankruptcy or otherwise;

33.1.3 shall require payment of the call and any accrued interest and all expenses that may have been incurred by the Company by reason of such non-payment by a date which is not fewer than 14 days after the date of the notice;

33.1.4 shall state how the payment is to be made; and

33.1.5 shall state that if the notice is not complied with, the Shares in respect of which the call is payable will be liable to be forfeited.

33.2 If a notice of intended forfeiture is not complied with before the date by which payment of the call is required in the notice of intended forfeiture, then the Directors may decide that any Share in respect of which it was given is forfeited, and the forfeiture is to include all dividends or other moneys payable in respect of the forfeited Shares and not paid before the forfeiture.

33.3 Subject to these Articles, the forfeiture of a Share extinguishes:

33.3.1 all interests in that Share, and all claims and demands against the Company in respect of it; and

33.3.2 all other rights and liabilities incidental to the Share as between the person whose Share it was prior to the forfeiture and the Company.

33.4 Any Share which is forfeited in accordance with these Articles:

33.4.1 shall be deemed to have been forfeited when the Directors decide that it is forfeited;

33.4.2 shall be deemed to be the property of the Company; and

33.4.3 may be sold, re-allotted or otherwise disposed of as the Directors think fit.

33.5 If a person's Shares have been forfeited then:

33.5.1 the Company shall send that person notice that forfeiture has occurred and record it in the register of members;

- 33.5.2 that person shall cease to be a Shareholder in respect of those Shares;
- 33.5.3 that person shall surrender the certificate for the Shares forfeited to the Company for cancellation;
- 33.5.4 that person shall remain liable to the Company for all sums payable by that person under the Articles at the date of forfeiture in respect of those Shares, including any interest (whether accrued before or after the date of forfeiture); and
- 33.5.5 the Directors shall be entitled to waive payment of such sums wholly or in part or enforce payment without any allowance for the value of the Shares at the time of forfeiture or for any consideration received on their disposal.
- 33.6 At any time before the Company disposes of a forfeited Share, the Directors shall be entitled to decide to cancel the forfeiture on payment of all calls and interest and expenses due in respect of it and on such other terms as they think fit.
- 33.7 If a forfeited Share is to be disposed of by being transferred, the Company shall be entitled to receive the consideration for the transfer and the Directors shall be entitled to authorise any person to execute the instrument of transfer.
- 33.8 A statutory declaration by a Director or the company secretary that the declarant is a Director or the company secretary and that a Share has been forfeited on a specified date:
 - 33.8.1 shall be conclusive evidence of the facts stated in it as against all persons claiming to be entitled to the Share; and
 - 33.8.2 subject to compliance with any other formalities of transfer required by the articles or by law, constitutes a good title to the Share.
- 33.9 A person to whom a forfeited Share is transferred shall not be bound to see to the application of the consideration (if any) nor shall that person's title to the Share be affected by any irregularity in or invalidity of the process leading to the forfeiture or transfer of the Share.
- 33.10 If the Company sells a forfeited Share, the person who held it prior to its forfeiture shall be entitled to receive the proceeds of such sale from the Company, net of any commission, and excluding any sum which:
 - 33.10.1 was, or would have become, payable; and
 - 33.10.2 had not, when that Share was forfeited, been paid by that person in respect of that Share,but no interest shall be payable to such a person in respect of such proceeds and the Company shall not be required to account for any money earned on such proceeds.

34 SURRENDER OF SHARES

- 34.1 A Shareholder shall be entitled to surrender any Share:
 - 34.1.1 in respect of which the Directors issue a notice of intended forfeiture;
 - 34.1.2 which the Directors forfeit; or
 - 34.1.3 which has been forfeited.The Directors shall be entitled to accept the surrender of any such Share.
- 34.2 The effect of surrender on a Share shall be the same as the effect of forfeiture on that Share.
- 34.3 The Company shall be entitled to deal with a Share which has been surrendered in the same way as a Share which has been forfeited.

35 AUTHORITY TO CAPITALISE AND APPROPRIATION OF CAPITALISED SUMS

- 35.1 The Board may, if authorised to do so by an ordinary resolution (with Founder Consent):
 - 35.1.1 decide to capitalise any profits of the Company (whether or not they are available for distribution) which are not required for paying a preferential dividend, or any sum standing to the credit of the Company's share premium account or capital redemption reserve; and

35.1.2 appropriate any sum which they so decide to capitalise (a "Capitalised Sum") to such Shareholders and in such proportions as the Board may in their absolute discretion deem appropriate (the "Shareholders Entitled").

Article 36 of the Model Articles shall not apply to the Company.

35.2 Capitalised Sums may be applied on behalf of such Shareholders and in such proportions as the Board may (in its absolute discretion) deem appropriate.

35.3 Any Capitalised Sum may be applied in paying up new Shares up to the nominal amount (or such amount as is unpaid) equal to the Capitalised Sum, which are then allotted credited as fully paid to the Shareholders Entitled or as they may direct.

35.4 A Capitalised Sum which was appropriated from profits available for distribution may be applied in paying up new debentures of the Company which are allotted credited as fully paid to the Shareholders Entitled or as they may direct.

35.5 Subject to the Articles the Board may:

35.5.1 apply Capitalised Sums in accordance with Articles 35.3 and 35.4 partly in one way and partly another;

35.5.2 make such arrangements as they think fit to deal with Shares or debentures becoming distributable in fractions under this Article 35; and

35.5.3 authorise any person to enter into an agreement with the Company on behalf of all of the Shareholders Entitled which is binding on them in respect of the allotment of Shares or debentures under this Article 35.
