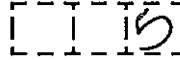

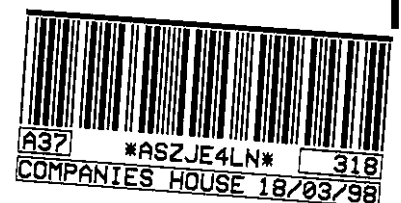

## NOTES
