- 1. <u>Sale Smith & Co. Limited</u>: On 11th September 2009, instructions were given to Messrs Sale Smith & Co. Limited to convene a statutory meeting of the creditors of the company, following the directors' decision to commence the voluntary winding up proceedings of the company.
