TABLE A

- 1. Subject as otherwise provided in these Articles, the regulations in Table A, Companies (Tables A to F) Regulations 1985 (SI 1985 No.805) (in these Articles referred to as "Table A") shall apply to the Company.
- 2. The following provisions of Table A shall not apply to the Company regulations 24 and in regulation 62(a) and (b) respectively: the words "not less than 48 hours" and "not less than 24 hours".

SHARES

3. Section 89(1) of the Companies Act 1985 ("the Act") shall not apply to the Company. Subject to the provisions of the Act relating to authority, pre-emption rights and otherwise and of any resolution of the Company in general meeting passed pursuant thereto, all unissued shares for the time being in the capital of the Company shall be at the disposal of the directors, and they may (subject as aforesaid) allot, grant options over, or otherwise dispose of them to such persons, on such terms and conditions, and at such times as they think fit during the period of five years from the date of incorporation of the Company and to the maximum amount of £600,000.



TRANSFER OF SHARES
