ORDER

UPON THE APPLICATION of the Applicants filed on 24 April 2013

AND UPON READING:

- (1) the Witness Statements of Andrew Matthew Martin dated 16 April 2013 and Mark Keith Adams dated 23 April 2013,



- (2) the written consent of each person proposed to be a replacement office-holder, namely Lee Antony Manning dated 2 April 2013, Neville Barry Kahn dated 8 April 2013, Daniel Francis Butters dated 28 March 2013 and Clare Boardman dated 28 March 2013, and
- (3) the written consent of each person who currently holds office with the Applicants, namely Philip Stephen Bowers dated 3 April 2013, Daniel Francis Butters dated 28 March 2013, Neville Barry Kahn dated 8 April 2013 and Dominic Lee Zoong Wong dated 5 April 2013

IT IS ORDERED THAT:

1. Transfer of Cases to High Court, London

- (1) the case numbered 4 in the Schedules hereto be transferred to the High Court of Justice, Chancery Division, London for the purpose only of the substantive application,
- (2) the case transferred pursuant to paragraph 1(1) be transferred back to Leeds District Registry when this application has been dealt with by the court

2. Block Transfer

- (1) In relation to the appointment set out in **Schedule 1** hereto, Angus Matthew Martin be removed and Lee Antony Manning be appointed as his replacement,
- (2) in relation to the appointments set out in **Schedule 2** hereto, Angus Matthew Martin be removed and Neville Barry Kahn be appointed as his replacement, with Philip Stephen Bowers continuing as office-holder in respect of those appointments with the said Neville Barry Kahn;
- (3) in relation to the appointment set out in **Schedule 3** hereto, Angus Matthew Martin be removed and Clare Boardman be appointed as his replacement, with Daniel Francis Butters continuing as joint liquidator in respect of that appointment with the said Clare Boardman;
- (4) Angus Matthew Martin be removed from office in respect of the appointments set out in **Schedule 4** hereto, and the remaining two office-holders for each case detailed in the said **Schedule 4** continue in office;
- (5) in relation to the appointment set out in **Schedule 5** hereto, Mark Keith Adams be removed and Philip Stephen Bowers and Neville Barry Kahn be appointed;

- (6) in relation to the appointment set out in Schedule 6 hereto, Mark Keith Adams be removed and Neville Barry Kahn be appointed as his replacement, with Philip Stephen Bowers continuing as joint administrator in respect of that appointment with the said Neville Barry Kahn,
- (7) the creditors in each case be notified of this order by advertisement in the London Gazette and at the time of the next statutory reporting requirement for each case;
- (8) that the costs of making this application shall be apportioned equally amongst the 15 cases listed in Schedules 1 to 6 hereto and that:
 - (i) where the case relates to an administration appointment, the pro rata share of the cost of this application shall be payable as an expense of the administration; and
 - (ii) where the case relates to any insolvency proceeding other than administration, the pro rata share of the cost of this application shall be payable as an expense of the insolvency proceedings,
- (9) Pursuant to paragraph (8) above the costs of making this application are summarily assessed in the sum of £3,500 in total plus VAT.
- (10) Permission to apply to vary paragraph (9) of this Order such application to be issued by no later than 4 00pm on Friday 5 July 2013
