## **BACKGROUND**

- 3.2 The Company was incorporated on 4 November 1986 as a company that deals with the manufacture of electricity distribution and control apparatus.



## 4. PROGRESS OF THE LIQUIDATION TO DATE

4.1 The manner in which the affairs and business of the Company has been managed since the appointment of the Joint Liquidators is set out below:

## 4.2 Creditors

- 4.2.1 The Company does not have any creditors per the Declaration of Solvency provided on 30 September 2019.
- 4.2.2 The Joint Liquidators gave notice to any potential creditors to prove their debts. A notice seeking creditors to prove was placed in the London Gazette on 3 October 2019, with a last date for proving being 1 December 2019. No creditor claims were received.

## 4.3 HM Revenue and Customs

- 4.3.1 Prior to the Liquidation the Company had not detailed any HM Revenue and Customs assets or liabilities on their Declaration of Solvency.
- 4.3.2 All outstanding returns have been submitted and the Joint Liquidators had written to HM Revenue and Customs to request clearance to close the Liquidation as both pre and post Liquidation tax affairs are up to date. The Joint Liquidators have received this formal clearance from HM Revenue and Customs.

## 4.4 Distribution to Members

- 4.4.1 The Joint Liquidators made two distributions to the sole member, Anord Control Systems (Holdings) Limited. The first distribution totalled £263,031.25 and was made on 30 September 2019. The second distribution totalled £2,457.55 and was made on 7 November 2019.
- 4.5 Statement of Expenses for the Period (Rule 18.4(d) of the Insolvency (England and Wales) Rules 2016)
  - 4.5.1 The Joint Liquidators' fees and expenses have been fixed per the Engagement Letter, dated 15 March 2019.
- 4.6 Further work required to conclude the Liquidation
  - 4.6.1 In order to conclude the Liquidation and obtain their release the Liquidator must deliver a final account as required by Section 94 of the Insolvency Act 1986 (as amended) to the Registrar of Companies.

Therefore, in accordance with Rule 5.10 of the rules the Liquidator gives notice that:

- The affairs of the Company are fully wound up
- The Liquidator will vacate office and be released under section 171 of the Insolvency Act 1986 on delivering the final account to the Registrar of Companies
- 4.6.2 The Joint Liquidators had intended on delivering the final account to the Registrar of Companies no later than 30 August 2021, however, the Member has consented to early conclusion on 30 June 2021.
