ORDER

UPON THE WINDING UP PETITION presented by Headington Investments Limited (in Administration) (the "**Company**") on 19 December 2019 (the "**Petition**"), acting by its joint administrators Joanne Robinson and Derek Hyslop of Ernst & Young LLP, 1 More London Place, London, SE1 2AF (together, the "**Joint Administrators**")

AND UPON READING the evidence filed

AND UPON HEARING Andrew Shaw, of counsel, for the Company

IT IS ORDERED that:

1. Pursuant to section 18 of the Insolvency Act 1986 (the "**Act**"), the order of Mr Justice Hoffmann dated 5 December 1991 be discharged.



2. Pursuant to section 20 of the Act, the Joint Administrators and John Andrew Talbot, Anthony William Brierley, Murdoch Lang McKillop and Martin Fishman (as former administrators of the Company) shall have their release from all liabilities in respect of any of their acts or omissions as administrators of the Company with effect from 28 days after the filing at court by the Joint Administrators of their final abstract of receipts and payments pursuant to rule 2.52 of the Insolvency Rules 1986, save in respect of any claim notified in writing to the Joint Administrators before that date.
3. The Company, with registered number 02195568, be wound up by the Court under the provisions of the Act.
4. The costs of and incidental to the Petition be paid as an expense in the winding up.
5. The Office-holders shall deliver a copy of this order to the Registrar of Companies and to all known creditors and contributories of the Company.


