EXECUTIVE SUMMARY

This final account has been prepared to provide members with an update on the progress of the Liquidation since our appointment as Joint Liquidator on 13 August 2019. I am now in a position to bring the liquidation to a close and further details regarding my actions as liquidator are detailed in this report.

LIQUIDATORS' ACTIONS SINCE APPOINTMENT

The Company's assets comprised an intergroup debt of £2.00 which was distributed in specie to the shareholders, Rensburg Sheppards Plc and Scarwood Nominees Limited on 30 September 2019.

Tax clearances were requested and have been received from HM Revenue & Customs.

There is certain work that I am required by the insolvency legislation to undertake in connection with the liquidation that provides no financial benefit for the members. A description of the routine work undertaken since my appointment is contained in Appendix 2.

RECEIPTS AND PAYMENTS ACCOUNT

My Receipts & Payments Account for the period from 13 August 2019 to date is enclosed at Appendix 1.

The intercompany debt in the sum of £2.00, due from group undertakings, was distributed in specie to the shareholders on 30 September 2019,

Whilst many of these tasks have not had a direct benefit in enhancing realisations, they have assisted in the efficient and compliant progressing of the liquidation, which has ensured that the Liquidator and his staff have carried out their work to high professional standards.
