1. Basis of Accounting

The accounts are prepared under the historical cost convention and in accordance with applicable accounting standards. The annual accounts are made up to 31 December 2014.

2. Parent Company

At 31 December 2014 the company's ultimate parent Company and controlling party was Mondelez International Inc., incorporated in the United States of America. This is the parent Company of the smallest and largest group to consolidate these financial statements. 3. Group Accounts

As permitted by the Companies Act 2006, the Company, being a wholly owned subsidiary of a Company incorporated in the United States of America, does not prepare group accounts.

For the year ended 31 December 2014, the Company is entitled to the exemption from audit conferred by subsection (1) of Section 480 of the Companies Act 2006 (the 'Act') and no notice has been deposited under subsection (2) of Section 476 of the Act requiring an audit of its accounts for the financial year.
