Please find enclosed a completed and signed copy of the Annual Return for Yorkshire Electricity Group plc (Company no: 2366995).

As discussed in a telephone call with yourselves on 16 September 1997, we are unable to provide a single list of changes to the Register of Members since, following the takeover of the Company earlier this year, the Registrars have not yet been able to process all the Register amendments.

We have, however, following consultation with yourselves, enclosed 2 microfiches showing:

- i) the Register of Members with the changes up to 28 May 1997, the closing date of the takeover offer; and
- ii) the dissenters register as at 9 August 1997.

As at the close of business on 28 May 1997 the Company had only 1 shareholder - Yorkshire Holdings plc. As at 16 September 1997 the Register of Members showed two shareholders (hard copy attached). There have been no changes to the Register since this date. Please note that our Registrars are in the process of reducing the holdings of all those shown on the dissenters register (2nd microfiche) to nil.
