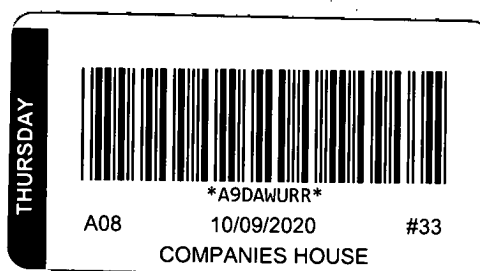

**Business Review**




The company did not trade during the current or preceding year and has made neither profit nor loss; nor any other recognised gain or loss.
