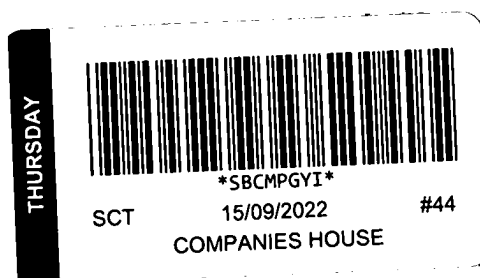

Statement of going concern
