REPORT OF THE COUNCIL

The Executive Council presents its report together with the accounts for the year ended 31 March 2017.

REVIEW OF BUSINESS

The Company, which is a registered charity, has been established to provide charitable assistance to the Bulgarian people. Friends of Bulgaria works to improve the quality of life of disadvantaged children and young people.

Friends of Bulgaria has no permanent staff or field operations, the charity raises funds and makes grants to charities working in Bulgaria and Bulgarian institutions on the basis of project proposals which are reviewed by the Executive Council. The Members of the Executive Council provide their services on an unremunerated basis, including administrative support.

There were no changes in the nature of these activities during the period.

RESULTS

The results for the period are shown in the Balance Sheet and Income and Expenditure Account attached to this report. These accounts have been prepared in accordance with the special provisions relating to companies subject to the small companies' regime.

The charity's annual Christmas Party, this year celebrating the 25th Anniversary of the charity, was held at the Bulgarian Embassy in London and raised just over £10,000 from ticket sales, auction proceeds and donations and was the principal fund raising activity during the period. The Executive Council also wish to thank Mr and Mrs Kamen Zahariev for generously nominating Friends of Bulgaria as their preferred charity on the occasion of their Wedding Anniversary party in July 2016, as a result of which Friends of Bulgaria received donations of £1,883.

EVENTS SINCE THE END OF THE PERIOD

A grant of £6,800 agreed by the Executive Council during the period was paid after the year end on 5th April 2017 to ZOV UK for two projects for special needs children's clubs and a crisis centre.

DISTRIBUTIONS

Friends of Bulgaria agreed support for the following charities and institutions with projects assisting children and young people with disabilities in Bulgaria in the year to 31 March 2017: OXAB, Star of Hope, Karin Dom and ZOV UK.

GOING CONCERN

The company has no running expenses and is administered on a voluntary basis, as such there are no liabilities and the Executive Council may make grants either from current year income or reserves. The company raises funds from time to time through events and donations and the financial statements have been prepared on a going concern basis that assumes further funding will be obtained.

CLOSE COMPANY

The company is a close company within the meaning of the provisions of ICTA 1988

EXECUTIVE COUNCIL

Members of the Executive Council during the year, unchanged from the previous year, were as follows: J C S M Brisby QC (Chairman), Dr G Kirov, Tom Gentleman, Claire Brisby, Julian Popov (Hon Secretary and Treasurer), Atanas Christev.

Katharine Hill resigned from the Executive Council at the end of 2016 and we are most grateful to her for her contribution over many years. In March 2017, Sabina Zlateva, who has helped the charity with fund raising for several years, joined the board as a member of the Executive Council.

These accounts have been prepared in accordance with the provisions applicable to companies subject to the small companies regime and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008). For the year ending 31 March 2017 the company was entitled to exemption under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.
