ORDER



UPON the application of James Douglas Ernle Money, Martha Hanora Catherine Thompson, Christopher Kim Rayment and Sarah Megan Rayment ("the Application")

AND UPON reading the Witness Statements of James Douglas Ernle Money and James Stewart-Koster

IT IS ORDERED THAT:

- The insolvency proceedings listed in the Schedules attached hereto which are not currently before the High Court be transferred to the High Court for the purposes of this Application only, and the Applicants to ensure that a sealed copy of this Order be lodged with the Court having jurisdiction over each case affected by this Order
- The First Respondent, James Stewart-Koster, be removed from his office as Liquidator in respect of the companies in Creditors' Voluntary Liquidation which are set out in Schedule A hereto
- The First Applicant, James Douglas Ernle Money, shall be appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule A hereto in which he is identified as proposed appointee
- The Second Applicant, Martha Hanora Catherine Thompson, shall be appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule A hereto in which she is identified as proposed appointee
- The First Respondent, James Stewart-Koster, be removed from his office as Liquidator in respect of the companies in Compulsory Liquidation which are set out in Schedule B hereto
- 6. The First Applicant, James Douglas Ernle Money, shall be appointed as Liquidator in substitution of the First Respondent in respect of the companies which are set out in Schedule B hereto
- 7. The First Respondent, James Stewart-Koster, be removed from his office as Administrator in respect of the companies in Administration which are set out in Schedule C hereto
- 8. The Second Applicant, Martha Hanora Catherine Thompson, shall be appointed as Administrator in substitution of the First Respondent in respect of the Company which is set out in Schedule C hereto in which she is identified as the proposed appointee. In respect of that company, the Second Applicant shall additionally replace the First Respondent as

the nominated joint-liquidator under the terms of the Administrators' proposals for the purposes of placing the company in Creditors' Voluntary or Compulsory Liquidation

- The Third Applicant, Christopher Kim Rayment, shall be appointed as Administrator in substitution of the First Respondent in respect of the company set out in Schedule C hereto in which he is identified as proposed appointee. In respect of that company, the Third Applicant shall additionally replace the First Respondent as the nominated joint-liquidator under the terms of the Administrators' proposals for the purposes of placing the company into Creditors' Voluntary or Compulsory Liquidation.
- The Fourth Applicant, Sarah Megan Rayment, shall be appointed as Administrator in substitution of the First Respondent in respect of the companies set out in Schedule C hereto in which she is identified as proposed appointee. In respect of those companies, the Fourth Applicant shall additionally replace the First Respondent as the nominated joint-liquidator under the terms of the Administrators' proposals for the purposes of placing the companies into Creditor's Voluntary or Compulsory Liquidation.
- The Applicants shall procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, a block advertisement in respect of each of the insolvency appointments listed in Schedules A, B and C shall be placed in the London Gazette containing notification of the following matters.
 - a. The removal of the First Respondent and the substitution of the First Respondent by the First, Second, Third or Fourth Applicant, as the case may be,
 - b. That creditors and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge this Order,
 - c. That creditors and debtors (where they have a financial interest in the outcome of the insolvency proceedings) have the right to object and make representations to the First Respondent in respect of his release within 28 days after the notice has been advertised, and
 - d That in the case of the Liquidations listed in Schedules A and B, the
 First Respondent will be entitled to apply to the Secretary of State for
 his release upon the expiry of 42 days from the date the notice has
 been advertised

- In relation to the insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency Rules 1986 contain any requirement for advertisement of the removal of the First Respondent or his substitution by the Applicants, the requirement shall be dispensed with save to the extent provided for herein Insofar as the First Respondent is required by law to give any notice of the removal from office, the Applicants (and each of them) are entitled to sign and send any such notice on her behalf
- 13. The period to be covered by progress reports to creditors and the dates by which those reports need to be sent to creditors and filed with the Registrar of Companies (if applicable) shall not be altered by virtue of the making of this Order or the replacement of the First Respondent by the First, Second, Third or Fourth Applicant, as the case may be, pursuant to this Order, and this provision shall override any requirement in the Insolvency Rules 1986 that would otherwise require a report to be made to creditors or would otherwise alter the period to be covered by progress reports or the dates by which those reports need to be sent to creditors and Companies House, on the termination, commencement of replacement of an officeholder's appointment, including those set out in rules 2.47(3A), 4.49B(5) and 4 49C-CVL(3) of the Insolvency Rules 1986.
- In each Liquidation listed in Schedules A and B hereto, the First Respondent shall not be at liberty to apply to the Secretary of State for his release until the expiry of 42 days from the date when the relevant notice referred to in paragraph 11 above has been placed in the London Gazette
- In each Administration listed in Schedule C hereto, the First Respondent be released from all liability both in respect of any of his acts and omissions in relation to his conduct as office holder of the estates with effect from 28 days from the date when the relevant notice referred to in paragraph 11 above has been placed in the London Gazette, save in respect of any claim notified to the First Respondent pursuant to the Insolvency Act 1986 and/pursuant to such other provision as may apply by that date.
- There be no order as to costs.
