We have examined the attached statutory declaration of the Directors dated 29 March 1995 in connection with the proposal that the Company should give financial assistance for the purchase of 700 of the Company's ordinary shares of 10p each. We have enquired into the state of the Company's affairs so far as necessary for us to review the bases for the statutory declaration.

We are not aware of anything to indicate that the opinion expressed by the Directors in their declaration as to any of the matters mentioned in section 156(2) of the Companies Act 1985 is unreasonable in all the circumstances.
