The directors present their annual report and the unaudited financial statements for the year ended 31 March 2016.

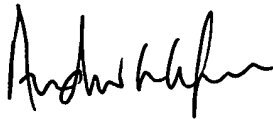
BUSINESS REVIEW

For the year ended 31st March 2016 the company was entitled to exemption from audit under section 480 of The Companies Act 2006 relating to dormant companies.

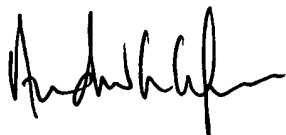
The members have not required the company to obtain an audit of its accounts for the year in accordance with section 476.
