The Directors present their report on the Company and the financial statements for the year ended 31 December 2018.

#### Principal activities, review of business and future developments

Rainey Kelly Campbell Roalfe Limited (the "Company"), a member of the WPP Plc Group (the "Group"), acts as a manager and agent of the digital artwork and reprographic technology business of WPP Brands (UK) Limited. The Company is considered dormant as defined in section 1169 of the Companies Act 2006 throughout the year. There was no transfer to or from reserves for the year. The Directors are of the opinion that the Company will remain dormant for the foreseeable future.

#### 1 Presentation of the financial statements

#### **General information**

Rainey Kelly Campbell Roalfe Limited is a dormant company. The Company is a private company, limited by shares, and is incorporated and registered in England and Wales. The address of the registered office is Greater London House, Hampstead Road, London, NW1 7QP.

### 2 Summary of significant accounting policies

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied, unless otherwise stated.

#### (a) Basis of preparation

The financial statements have been prepared in accordance with Financial Reporting Standard 100 Application of Financial Reporting Requirements ("FRS 100") and Financial Reporting Standard 101 Reduced Disclosure Framework ("FRS 101").

The financial statements have been prepared on the going concern basis under the historical cost convention, and in accordance with the Company Act 2006.

#### Disclosure exemptions adopted

In preparing the financial statements the Company has taken advantage of all disclosure exemptions conferred by FRS 101. Therefore, the financial statements do not include:

- Paragraph 30 and 31 of IAS 8 'Accounting policies, changes in accounting estimates and errors' (requirement for the disclosure of information when an entity has not applied a new IFRS that has been issued but is not yet effective);
- Paragraph 17 of IAS 24, 'Related party disclosures' (key management compensation);
- The requirements in IAS 24, 'Related party disclosures' to disclose related party transactions entered into between two or more wholly owned members of a group.

The preparation of financial statements in conformity with FRS 101 requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Company's accounting policies. As the Company is dormant, the directors confirm that no significant accounting judgements or critical estimates apply to the Company.

# (b) Ultimate and immediate parent undertaking

The Company is a wholly owned subsidiary of the ultimate parent company. WPP plc, a company incorporated in Jersey, is the Company's ultimate parent undertaking and controlling party. The largest group of undertakings for which group financial statements are prepared and which include the results of the Company are the consolidated financial statement of WPP plc. The smallest group of undertakings for which group financial statements are prepared and which include the results of the Company are the consolidated financial statements of WPP Jubilee Limited, registered in England and Wales. The immediate parent undertaking is WPP Brands Development (Holdings) Limited. These financial statements are separate financial statements.

#### (c) Trade and other receivables

Trade and other receivables are carried at original invoice amount less any provisions for doubtful debts. Provisions are made where there is evidence of a risk of non-payment, taking into account ageing, previous experience and general economic conditions. When a trade or other receivable is determined to be uncollectable it is written off, firstly against any provisions available and then to the income statement.

Subsequent recoveries of amounts previously provided for are credited to the income statement. Long-term receivables are discounted where the effect is material.

With effect from that date, the company has continued to trade acting as manager and agent for WPP Brands (UK) Limited.
