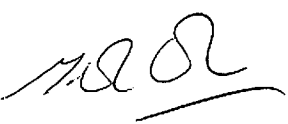

This is my annual progress report under section 92A of the Insolvency Act ('the Act') and Rules 18.3 and 18.7 of the Insolvency (England and Wales) Rules 2016 ('the Rules'). This report covers the period from 31 December 2020 to 30 December 2021 ('the Period').

#### Statutory Information

I, Malcolm Cohen of BDO LLP, 55 Baker Street, London, W1U 7EU (officeholder number 6825) and Matthew Chadwick of BDO LLP, 2 City Place, Beehive Ring Road, Gatwick, RH6 0PA (officeholder number 9311), both authorised insolvency practitioners were appointed Joint Liquidators of the Company on 25 January 2021 by resolutions passed by the Companies' respective members.

The Companies were placed into members' voluntary liquidation on 31 December 2019 with Ian Dean and Stephen Browne of Deloitte LLP, 1 New Street Square, London, EC4A 3HQ. The original Joint Liquidators had to resign due to a conflict of interest that arose during their period of appointment.

### **Receipts and Payments**

I enclose Receipts and Payments accounts for the Period showing a balance of nil in hand. The account shows that there have been no transactions in the Period together with the amounts shown on the Statement of Assets and Liabilities included in the Declaration of Solvency sworn by the Directors for the Companies.

The Joint Liquidators' expenses are discussed in further detail later in this report.

### **Creditors**

No creditor claims were expected and no claims have been received.

### **HM Revenue & Customs ('HMRC')**

As a matter of course we obtain clearances from the corporation tax office, and the Enforcement & Insolvency Service ('EIS') which deals with VAT and PAYE and issues HMRC's claim for all taxes.

The original Joint Liquidators obtained corporation tax clearances during their period of appointment. They also made application to remove the Companies from VAT groups, however, the applications coincided with the UK's first lockdown resulting from the COVID-19 pandemic. As a result, the applications were not considered for some months.

In the interim, the Companies' parent group took advantage of the deferral of VAT payments that was made available by HMRC. As a consequence, the Companies, being part of the VAT groups, were jointly and severally liable for the deferred VAT, and HMRC refused to confirm that the Companies have been removed from the VAT groups or issue clearances.

We have now been informed by the Companies' parent group that the deferred VAT has been settled, and we will seek final clearances from EIS.

### **Distributions**

First and final distributions in specie of the intercompany debtor balances owed to the Companies will be made to their respective members when we are in a position to close the liquidations.

### **Outstanding Matters**

Once final tax clearances have been received from HMRC we should be in a position to close the liquidations.



### **Joint Liquidators' remuneration**

The Joint Liquidators are obliged to fix their remuneration in accordance with Rule 18.16. This permits remuneration to be fixed either:

- (1) As a percentage of the assets realised and distributed; and/or
- (2) By reference to the time the Joint Liquidators and their staff have spent attending to matters in the Liquidation; and/or
- (3) As a set amount; and/or
- (4) As a combination of the above.

The Joint Liquidators' remuneration has been approved on a time costs basis.

BDO LLP changed time recording systems with effect from 17 April 2021.

I therefore attach two detailed reports for each Company of the time incurred by the Joint Liquidators for the periods:

- 17 April 2021 to 30 December 2021
- 25 January 2021 to 16 April 2021

The two reports read in conjunction cover the total time incurred by the Joint Liquidators in the Period.

In the Period time costs of £8,490 have been incurred over 14.1 hours spent at an average charge out rate of £610 per hour. As the Companies do not have any cash assets, the costs of liquidation, including expenses, will be met by their parent group. No fees have been drawn in this regard to date.

With regards to the time incurred on the schedules, I can provide further details on the work undertaken during the Period which includes the following: -

#### Pre-appointment

- Liaising with the directors, members, parent group, and former Joint Liquidators regarding the Companies' affairs
- Preparing the relevant documentation for the appointment of the Joint Liquidators

#### Steps on appointment

- Set up of case files and initial data input including basic details of the case
- Preparing and filing of initial statutory forms with the Registrar of Companies and the notice to creditors to claim for advertisement in the London Gazette

#### General Administration

- General administration of the cases
- Preparation and completion of internal reviews
- Correspondence with HMRC to advise of our appointments

### Reporting

- Preparation of the annual progress report

### **Members' rights**

Within 21 days of receipt of this progress report, members with at least 5% in value of the total voting rights of all members having the right to vote at general meetings of the Company or any member with the permission of court, may request in writing that the Joint Liquidators provide further information about their remuneration or expenses which have been itemised in this progress report.

Within 14 days of receipt of the request, the Joint Liquidators must provide all of the information asked for, unless they think that:

- the time or cost in preparing the information would be excessive, or
- disclosure of the information would be prejudicial to the conduct of the Liquidation or might reasonably be expected to lead to violence against any person, or
- they are subject to confidentiality obligations in respect of the information.

The Joint Liquidators are also required to give reasons for not providing all of the requested information.





Members with at least 10% in value of the total voting rights of all members having the right to vote at general meetings of the Company may, within eight weeks of receipt of the Progress Report, make an application to court that the basis fixed for the Joint Liquidators' remuneration, the remuneration charged, or the expenses incurred by the Joint Liquidators, as set out in this progress report, are excessive.
