ASSETS SPECIFICALLY PLEDGED

Lloyds TSB Bank PLC was granted a debenture securing fixed and floating charges on 21 April 1999. As the charge was created prior to 15 September 2003, the prescribed part allocation for non preferential creditors under s176A of the Insolvency Act 1986 will not apply

The company also entered into a factoring agreement with Lloyds TSB Commercial Finance Limited which was granted a debenture securing fixed and floating charges. There is currently no amount outstanding under the agreement
