Principal Activities

Doris Ernsting has continued in office as the sole director throughout the year.

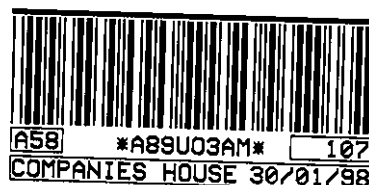
Results
