The directors present their report and accounts for the year ended 30 April 2007

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's governing document, applicable law and the requirements of the Statement of Recommended Practice, "Accounting and Reporting by Charities" issued in October 2000

Objectives and activities

Northern Sights was established in 1993 as a charitable company, limited by guarantee and not having a share capital. It is governed by its Memorandum and Articles of Association.

Northern Sights' aims are to foster and promote the arts in society by developing public appreciation of the arts and by improving public access to and quality of the arts

Last year the company undertook the management of the Art on the Riverside project. Originally a lottery project developed to increase public art within Tyne & Wear, this is collaborative project involving Newcastle, North Tyneside, South Tyneside and Sunderland local authorities. Newcastle have completed their project but Northern Sights will work with the remaining authorities to develop and monitor their projects through to completion, in line with the original contract and subsequent novation agreement.

Achievements and Performance

During the year Northern Sights continued to manage the Arts on the Riverside projects and distributed funds to the local authorities in line with the novation agreement. All projects remain on track and are regularly monitored by the Commissions North Officer at Arts Council England, North East

None of the directors has any beneficial interest in the company. All of the directors are members of the company and guarantee to contribute £1 in the event of the company winding up

Review of financial position

The year to April 2007 showed a surplus of £2,093 which was as a result of the grant from Arts Council England in relation to the Art on the Riverside projects. This money will be carried forward and expended in 2007/08

Reserves policy

Northern Sights operates on a project-by-project basis, with each project budgeted to break-even over its full course Hence, any surpluses or deficits arising at any given year-end need to be viewed in the light of the fact that the company will return to a break-even position at the end of each major project

Risk factors

The directors have assessed the major risks to which the charity is exposed, and are satisfied that systems are in place to mitigate exposure to the major risks
