The directors present their report and accounts for the year ended 30 April 2010

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the charity's governing document, applicable law and the requirements of the Statement of Recommended Practice, "Accounting and Reporting by Charities" issued in March 2005

Objectives and activities

Northern Sights was established in 1993 as a charitable company, limited by guarantee and not having a share capital. It is governed by its Memorandum and Articles of Association.

Northern Sights' aims are to foster and promote the arts in society by developing public appreciation of the arts and by improving public access to and quality of the arts

In 2007 the company undertook the management of the Art on the Riverside project Originally a lottery project developed to increase public art within Tyne & Wear, this is collaborative project involving Newcastle, North Tyneside, South Tyneside and Sunderland local authorities. All projects have now been completed and all monies received and granted in the year.

Achievements and Performance

During the year the Arts on the Riverside projects came to an end. Final payment was made to South Tyneside Council, and the balances on Sunderland City Council and North Tyneside Council were withdrawn due to incompletion of the project. These balances were retained by Arts Council England, and not delegated to Northern Sights. There was a balance left on the administration grant and this was paid to Northern sights and remains in the reserves for the year.

Public Benefit

The activities funded through the Art of the Riverside projects are Public Art commissions. These commissions are available to the general public and have a large impact on the local communities which they are based and the people within them.

The interactive lighting commission 'Flash' at Hebburn has continued to be popular with press articles and public engagement, in particular the artist raised additional funding for a high quality publication which documents the process which the project went through from initial research at the local Reyrolles electrical company through to fabrication and launch on site. The Flash book was launched at a community event in Hebburn Library at Easter 2010.

Directors

None of the directors has any beneficial interest in the company. All of the directors are members of the company and guarantee to contribute £1 in the event of the company winding up

All directors are appointed in accordance with Paragraphs 31 - 37 of the Articles of Association of the company

Review of financial position

The year to April 2010 showed a surplus of £6,155 which was as a result of the grant from Arts Council England in relation to the administration of the Art on the Riverside projects. This money remains unspent and is currently included in the final reserves.

Reserves policy

Northern Sights operates on a project-by-project basis, with each project budgeted to break-even over its full course. The Art on the Riverside project resulted in accumulated surplus, which is currently sitting in reserves.

Risk factors

As the Art on the Riverside is now complete, the board held an Extraordinary General meeting on 25 June 2010, agreeing to cease trading and donate £40,000 to Tyne & Wear Community Foundation The company will be retained as a dormant company
