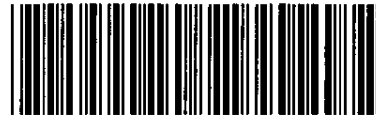

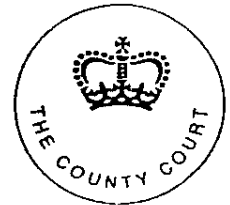

UPON THE APPLICATION by a Claim Form dated the 24 January 2022 of Master Riley Jay Dexter (acting by his Litigation Friend Jay Dexter) the Claimant and a creditor of the above named International Motor Sports Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 2 March 2022

AND ON the leave of the Court being given to amend the Claim Form to reflect the correct Company name on its second page and re-service being dispensed with

AND UPON the Claimant by their solicitors undertaking to:

- (A) inform the Registrar of Companies of the title and Court reference number of the proposed litigation referred to in paragraph 9 of the Witness Statement of Mike Molloy dated the 23 November 2021 immediately after issue
- (B) inform the Registrar of Companies immediately on the conclusion of the said proposed litigation or any appeal therefrom or the conclusion of the claim against the Company by any other means

AND UPON the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

(1) the name of the above named International Motor Sports Limited  
be restored to the Register of Companies

(2) if at the date of registration of this Order with the Registrar of  
Companies the name of the Company is not available the  
Registrar of Companies shall pursuant to Section 1033(2)(a)(ii)  
and (b) of the Companies Act 2006 change the name of the  
Company to 02979954 Limited

(3) an Office Copy of the Order be delivered to the Registrar of  
Companies and pursuant to the above mentioned Act the  
Company is thereupon to be deemed to have continued in  
existence as if its name had not been struck off

(4) the Registrar of Companies do advertise notice of this Order in her  
official name in the "London Gazette"



(5) the Claimant do pay to the Registrar of Companies her costs of the  
said Application in the agreed sum of £300-00

(6) the hearing fixed for the \_\_\_\_\_ at 2:00 pm be vacated
