
The director acknowledges his responsibility for:

1. Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective June 2002).

Turnover

The turnover shown in the income and expenditure account represents amounts invoiced during the year.

2. Related party transactions

During the year the company purchased services in the normal course of business from a business run by the director, at a cost of £4,942 (2004: £1,075). Amounts owed to this business amounted to £343 (2004:£325) at 31st January 2005.

During the year the company purchased services for £2,115 (2004 £nil) in the normal course of business from a limited company in which the M J Steele is the sole director and 50% shareholder.

3. Company limited by guarantee

The association is a company limited by guarantee without share capital. The liability of each member is limited to £1.
