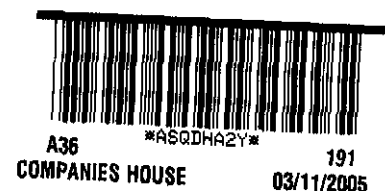

UPON HEARING COUNSEL FOR THE APPLICANTS AND UPON READING THE  
EVIDENCE

AND THE RESPONDENT CONSENTING TO AN ORDER IN THE TERMS SET OUT  
BELOW

IT IS HEREBY ORDERED that:-

1. Each of the matters, including the liquidations, individual voluntary arrangements and bankruptcies, listed in the schedules annexed hereto as being within the jurisdiction of the County Court be transferred to the High Court at 10.30 am on Friday 16<sup>th</sup> September 2005 for the purposes of effecting the replacement of the Respondent, whether in his capacity as sole or joint, officeholder in accordance with the terms of this application;
2. Ian Nigel Millington be removed as the officeholder, or where appropriate one of the officeholders, in the cases referred to in the Schedules annexed to this application;
3. The First Applicant Matthew Colin Bowker be appointed as the supervisor of the company voluntary arrangement listed in the First Schedule in respect of which an order is made under paragraph 2;
4. The Second Applicant Suzanne Payne be appointed as joint administrator of the administrations listed in Part 1 of the Second Schedule in respect of which an order is made under paragraph 2;
5. The First Applicant Matthew Colin Bowker be appointed as the administrator of the administration in Part 2 of the Second Schedule in respect of which an order is made under paragraph 2;
6. The First Applicant Matthew Colin Bowker be appointed as the liquidator of the members' voluntary liquidation listed in the Third Schedule in respect of which an order is made under paragraph 2;
7. The First Applicant Matthew Colin Bowker be appointed as the liquidator of the creditors' voluntary liquidations listed in the Fourth Schedule in respect of which an order is made under paragraph 2;
8. The First Applicant Matthew Colin Bowker be appointed as the liquidator of the compulsory liquidations listed in Part 1 of the Fifth Schedule in respect of which an order is made under paragraph 2;

9. The Second Applicant Suzanne Payne be appointed as the joint liquidator of the compulsory liquidations listed in Part 2 of the Fifth Schedule in respect of which an order is made under paragraph 2;
10. The Second Applicant Suzanne Payne be appointed as supervisor of the IVAs listed in the Sixth Schedule in respect of which an order is made under paragraph 2, and
11. The Second Applicant Suzanne Payne be appointed as trustee in bankruptcy of the bankruptcies listed in the Seventh Schedule in respect of which an order is made under paragraph 2;
12. The Debtor in each case listed in the First Schedule and the Sixth Schedule be notified of this order as soon as it is practicable to do so;
13. The members of the company listed in the Third Schedule be notified of this order as soon as it is practicable to do so;
14. That the creditors in each case listed in the Schedules annexed to this application be notified of this order at the same time as the officeholder in each case is required to report to them in accordance with the provisions of the Insolvency Act 1986 and Insolvency Rules 1986.
15. The costs of this application shall be apportioned on a pro rata basis between each case listed in the Schedules annexed to this application and paid as an expense of that particular insolvency or voluntary arrangement save that in no circumstances should the costs payable pursuant to the order in relation to an insolvency or voluntary arrangement exceed 10% of the value of the realised assets in that particular insolvency or voluntary arrangement subject to a reasonable decision of a properly constituted creditors' committee or Registrar as to whether the costs should be borne in the amount claimed or at all in any particular insolvency or voluntary arrangement.
16. Each of the matters, including the liquidations, individual voluntary arrangements and bankruptcies, listed in the schedules annexed hereto as being within the jurisdiction of the County Court but transferred to this court for the purposes of paragraphs 2 to 14 above shall be transferred back to the County Court at 11.30 am Friday 16<sup>th</sup> September 2005.
