

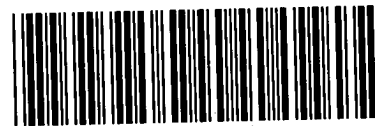

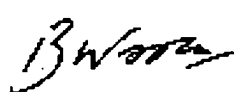

ORDER

UPON the application of Ben Woolrych ("Applicant") for a Block Transfer Order dated 14 September 2021

AND UPON READING the witness statement of the Applicant dated 14 September 2021 in support of the Application and the Respondents consenting to the Application

IT IS ORDERED that:

1. The cases listed in Schedules 1 to 6 (attached to this order) (each described as a **"Block Transfer Case"** and together **"Block Transfer Cases"**), in so far as they may currently be proceedings in a County Court, or other Business and Property Court of the High Court of Justice, those proceedings be transferred to the Business and Property Courts in Manchester, solely for the purpose of making this order.
2. Immediately upon this order taking effect, the Block Transfer Cases transferred to the Business and property Courts in Manchester pursuant to paragraph 1 above, be transferred back to the relevant County Court or other Business and Property Court of the High Court of Justice.
3. The Applicant (**"Outgoing Officeholder"**) be removed from office in respect of the Block Transfer Cases listed in Schedules 1 to 6 from the date of this order.
4. Anthony Collier of FRP Advisory Trading Limited, 4th Floor, Abbey House, 32 Booth Street, Manchester M2 4AB (**"Replacement Officeholder 1"**) be appointed as the joint replacement officeholder in respect of each Block Transfer Case listed in Schedule 1 from the date of this order.
5. Lila Thomas of FRP Advisory Trading Limited, Derby House, 12 Winckley Square, Preston, PR1 3JJ (**"Replacement Officeholder 2"**) be appointed as joint replacement officeholder in respect of each Block Transfer Case listed in Schedule 2 from the date of this order.
6. David Acland of FRP Advisory Trading Limited, Derby House, 12 Winckley Square, Preston, PR1 3JJ (**"Replacement Officeholder 3"**) be appointed as joint replacement officeholder in respect of the Block Transfer Case listed in Schedule 3 from the date of this order.
7. Paul Atkinson of FRP Advisory Trading Limited, Jupiter House, Warley Hill Business Park, The Drive, Brentwood, CM13 3BE (**"Replacement Officeholder 4"**) be appointed as joint replacement officeholder in respect of the Block Transfer Case listed in Schedule 4 from the date of this order.
8. Tony Wright of FRP Advisory Trading Limited, 110 Cannon Street, London, EC4N 6EU (**"Replacement Officeholder 5"**) be appointed as joint replacement officeholder in respect of the Block Transfer Case listed in Schedule 5 from the date of this order.
9. The creditors, in each of the Block Transfer Cases be notified of this order by placing a block transfer advertisement in the London Gazette within 28 days of the date of this order.

10. Any creditor, in respect of any of the Block Transfer Cases who has an objection to this order shall have 28 days from the date of the advertisement published in accordance with paragraph 7 above to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the court.
11. Replacement Officeholder 1 appointed pursuant to paragraph 4 above shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations and administrations listed Schedule 1 of the terms of this order as soon as reasonably practicable.
12. Replacement Officeholder 2 appointed pursuant to paragraph 5 above shall give notice to the Secretary of State in respect of the bankruptcy cases listed Schedule 2 of the terms of this order as soon as reasonably practicable.
13. Replacement Officeholder 3 appointed pursuant to paragraph 6 above shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidation case listed Schedule 3 of the terms of this order as soon as reasonably practicable.
14. Replacement Officeholder 4 appointed pursuant to paragraph 7 above shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidation case listed Schedule 4 of the terms of this order as soon as reasonably practicable.
15. Replacement Officeholder 5 appointed pursuant to paragraph 8 above shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidation case listed Schedule 5 of the terms of this order as soon as reasonably practicable.
16. The Outgoing Officeholder shall file a copy of this order with each of the courts listed in Schedules 1 to 6.
17. Nothing in this order shall release the Outgoing Officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the Block Transfer Cases.
18. The Outgoing Officeholder shall:
 - a. be at liberty to apply to the Secretary of State for his release as voluntary liquidator pursuant to section 173(2)(b)(ii) of the Insolvency Act 1986 ("Act") and for his release as Trustee in Bankruptcy pursuant to section 299(3)(b)(ii) of the Act; and
 - b. receive his discharge as administrator pursuant to Paragraph 98(2)(c) of Schedule B1 of the Act;

14 days after the giving of notice to creditors in accordance with this order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 8 of this order for the specific case subject to that application.

19. No order as to costs.
