 - "Each trustee shall be appointed for a three-year term and shall resign at the next annual general meeting held after the expiration of the three-year term. At the same annual general meeting such trustee shall be eligible for re-election for a further period of three years, PROVIDED that no director may serve for a continuous period in excess of nine years."
- 4 **THAT** the Company's article of association be altered by the deletion of the word "sixth" from article 38 and the substitution of it with the word "ninth"
