MEMORANDUM OF ASSOCIATION

OF

ENGLAND AND WALES CRICKET BOARD LIMITED

1. In this Memorandum of Association:

"Company"

shall mean England and Wales Cricket

Board Limited;

"Territory"

shall mean England, Wales, the Isle of Man

and the Channel Islands;

"Cricket"

shall mean cricket of all kinds and at all levels, both professional and recreational, and any other game or activity related or connected directly or indirectly, and however remotely, to or with cricket.

- 2. The Company's name is "England and Wales Cricket Board Limited".
- 3. The Company's registered office is to be situated in England.
- 4. The Company's objects are:
 - (A) to be the governing body of all Cricket in the Territory;
 - (B) the commercial promotion and exploitation of Cricket at all levels, whether or not in the Territory, including the organisation, administration and financing of competitive Cricket;
 - (C) to take responsibility for, organise, promote, facilitate and administer the game of Cricket at all levels, whether or not in the Territory, and to undertake any and all activities directly or indirectly associated therewith;
 - (D) to encourage maximum participation and interest in the game of Cricket, to improve playing standards at all levels and to uphold and enhance the traditions and spirit of the game of Cricket;
 - (E) the regulation of relations between cricketers and those by whom they are employed or for whom they play;

- (F) to obtain and maintain membership of the International Cricket Council or any other body formed in the future to fulfil the functions and role currently fulfilled by the International Cricket Council or any part thereof;
- (G) the fulfilment of all such roles and functions previously fulfilled by the Cricket Council, the Test and County Cricket Board and the National Cricket Association respectively as may be considered appropriate; and
- (H) the doing of all such other things as are incidental or conducive to the attainment of the objects set out in sub-clauses (A) to (G) above or any of them.
- 5. The liability of the members is limited.
- 6. Every member undertakes to contribute to the Company's assets, if it should be wound up while he is a member or within one year after he ceases to be a member, such amount as may be required (not exceeding £10) for payment of the Company's debts and liabilities contracted before he ceases to be a member, and of the costs, charges and expenses of winding up, and for the adjustment of the rights of the contributories among themselves.

ARTICLES OF ASSOCIATION

OF

ENGLAND AND WALES CRICKET BOARD LIMITED

PRELIMINARY

1. Regulations 2 to 35 inclusive, 54, 55, 57, 59, 102 to 108 inclusive, 110, 114, 116 and 117 of Table A, shall not apply to the company but the articles hereinafter contained and, subject to the modifications hereinafter expressed, the remaining regulations of Table A shall constitute the articles of association of the company.

INTERPRETATION

2. In regulation 1 of Table A, the definition of "the holder" shall be omitted.

MEMBERS

- 3. The subscribers to the memorandum of association of the company and such other persons as are admitted to membership in accordance with the articles shall be members of the company. No person shall be admitted a member of the company unless he is approved by the directors. Every person who wishes to become a member shall deliver to the company an application for membership in such form as the directors require executed by him.
- 4. A member may at any time withdraw from the company by giving at least seven clear days' notice to the company. Membership shall not be transferable and shall cease on death.

NOTICE OF GENERAL MEETINGS

5. In regulation 38 of table A -

- (a) in paragraph (b) the words "of the total voting rights at the meeting of all the members" shall be substituted for "in nominal value of the shares giving that right" and
- (b) the words "The notice shall be given to all the members and to the directors and auditors" shall be substituted for the last sentence.

PROCEEDINGS AT GENERAL MEETING

- 6. The words "and at any time separate meeting of the holders of any class of shares in the company" shall be omitted from regulation 44 of Table A.
- 7. Paragraph (d) of regulation 46 of Table A shall be omitted.

VOTES OF MEMBERS

8. On a show of hands every member present in person shall have one vote. On a poll every member present in person or by proxy shall have one vote.

DIRECTORS' EXPENSES

9. The words "of any class of shares or" shall be omitted from regulation 83 of Table A.

PROCEEDINGS OF DIRECTORS

10. In paragraph (c) of regulation 94 of Table A the word "debentures" shall be substituted for the words "shares, debentures or other securities" in both places where they occur.

MINUTES

11. The words "of the holders of any class of shares in the company" shall be omitted from regulation 100 of Table A.

NOTICES

12. The second sentence of regulation 112 of Table A shall be omitted.

The words "or of the holders of any class of shares in the company" shall be 13. omitted from regulation 113 of Table A.
