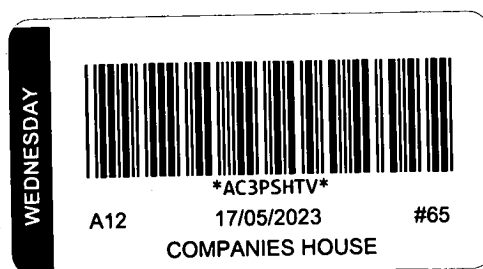

## Director's Report

The director presents his report and the financial statements for the year ended 31 December 2022.

### Principal Activity and business review

The principal activity of the company is to provide financing to subsidiary undertakings of General Electric Company.

Net assets have decreased from \$76,709,000 in 2021 to \$48,791,000 at 31 December 2022.

### Results and dividends

The loss for the year, after taxation, amounted to \$27,918,000 (2021: Profit \$330,000).

The director did not recommend the payment of a dividend (2021: \$nil).

### Directors of the company

The directors who held office during the year and at the date of the director's report were as follows:

### Political and charitable contributions

The company did not make any political or charitable donations in the year (2021: \$nil).

### Future developments

The director is not expecting a change in the principal activity of the company in the foreseeable future.

On 9 November 2021, General Electric Company (GE) announced that it would form three global listed companies that are intended to be run independently and focus on the aerospace, healthcare, and energy segments. In this context, GE plans to spin off 80.1% of its Healthcare business in early 2023 and retain a 19.9% interest in GE Healthcare after the spin-off. In addition, GE Digital, Renewables and Power businesses are planned to be combined into one business and spun off from GE in early 2024. Following these transactions, GE is expected to be an aviation-focused company shaping the future of flight while retaining certain other assets and liabilities including its runoff insurance operations. On 3 January 2023 the spin-off of the healthcare entities was completed. All healthcare entities ownership has changed and their ultimate parent company and controlling party is GE HealthCare Technologies Inc.

At the date of signing these financial statements there has been no impact from these transactions on this entity.

## Director's Report

### Going concern

The company has net assets of \$48,791,000 as at 31 December 2022 (2021: \$76,709,000) and a loss for the year ended of \$27,918,000 (2021: Profit \$330,000).

The director has performed a going concern assessment for a period of 12 months from the date of approval of these financial statements, also considering events reasonably foreseeable beyond this horizon, which indicates that, taking account of the inflationary impacts in the UK economy, in light of the company's ability to access the group's cash pool facility if required, the company will have sufficient funds to meet its liabilities as they fall due for that period.

The director is confident that the company will have access to sufficient funds to continue in operational existence for at least 12 months from the date of approval of these financial statements and they continue to adopt the going concern basis of accounting in preparing the annual financial statements.

### Financial risk management objectives and policies

#### Interest rate risk

The company is exposed to interest rate risk arising out of amounts owed to group undertakings. The exposure to interest rate risks have not been hedged as there is no net interest rate risk at a group level on intra-group borrowings.

#### Foreign currency risk

The company monitors and manages the foreign currency risk in relation to its operations in line with the group's policy and with the help of the global treasury team.

#### Liquidity risk

The company is exposed to short term fluctuations in cash flow to fund working capital requirements. The company has the ability to access the group's cash pool facility as and when required which helps in managing liquidity risk.

#### Other risks

The company is not exposed to significant credit risk other than on amounts owed by group undertakings on which it places reliance on the group's overall financial position.

### Post balance sheet event

On 3 May 2023, the company received \$218,015,000 from the Inland Revenue Services of the United States of America (IRS) in respect of claims made to repayment of US tax and interest on overpaid US tax on the basis that credit is due in the US for the additional UK tax paid in November 2021 for the years 2003 to 2008 (see Notes 11 and 15).

### Director's liabilities

The director has benefited from qualifying third party indemnity provisions in place during the financial year in respect of this entity and subject to the conditions set out in section 234 of the Companies Act 2006. Such qualifying third party indemnity provisions remain in force as at the date of approving the director's report. One or more directors of the immediate parent undertaking of this entity have benefitted from the same qualifying indemnity provisions.



### Statement of Director's Responsibilities

The director is responsible for preparing the Annual Report and the financial statements in accordance with applicable law and regulations.

Company law requires the director to prepare financial statements for each financial year. #### Opinion

In our opinion the financial statements of GE Financial Investments (the 'company'):

We have audited the financial statements which comprise:

The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 101 "Reduced Disclosure Framework" (United Kingdom Generally Accepted Accounting Practice).

#### Basis for opinion

### **Extent to which the audit was considered capable of detecting irregularities, including fraud**

In common with all audits under ISAs (UK), we are also required to perform specific procedures to respond to the risk of management override. In addressing the risk of fraud through management override of controls, we tested the appropriateness of journal entries and other adjustments; assessed whether the judgements made in making accounting estimates are indicative of a potential bias; and evaluated the business rationale of any significant transactions that are unusual or outside the normal course of business.

In addition to the above, our procedures to respond to the risks identified included the following:

- reviewing financial statement disclosures by testing to supporting documentation to assess compliance with provisions of relevant laws and regulations described as having a direct effect on the financial statements;
- performing analytical procedures to identify any unusual or unexpected relationships that may indicate risks of material misstatement due to fraud;
- enquiring of management and legal counsel concerning actual and potential litigation and claims, and instances of non-compliance with laws and regulations; and
- reading minutes of meetings of those charged with governance.

### **Report on other legal and regulatory requirements**

#### **Opinions on other matters prescribed by the Companies Act 2006**

In our opinion, based on the work undertaken in the course of the audit:

- the information given in the directors' Report for the financial year for which the financial statements are prepared is consistent with the financial statements; and

In the light of the knowledge and understanding of the company and its environment obtained in the course of the audit, we have not identified any material misstatements in the Directors' report.



### 2 Accounting policies

#### Summary of significant accounting policies and key accounting estimates

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

#### Basis of preparation

These financial statements were prepared in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework ("FRS 101").

In preparing these financial statements, the company applies the recognition, measurement and disclosure requirements of international accounting standards in conformity with the requirements of the Companies Act 2006 ("Adopted IFRSs"), but makes amendments where necessary in order to comply with Companies Act 2006 and has set out below where advantage of the FRS 101 disclosure exemptions has been taken.

The preparation of financial statements in compliance with FRS 101 requires the use of certain critical accounting estimates. It also requires management to exercise judgement in applying the company's accounting policies (see note 3).

#### Going Concern

The company has net assets of \$48,791,000 as at 31 December 2022 (2021: \$76,709,000) and a loss for the year ended of \$27,918,000 (2021: Profit \$330,000).

The director has performed a going concern assessment for a period of 12 months from the date of approval of these financial statements, also considering events reasonably foreseeable beyond this horizon, which indicates that, taking account of the inflationary impacts in the UK economy, in light of the company's ability to access the group's cash pool facility if required the company will have sufficient funds to meet its liabilities as they fall due for that period.

#### Basis of measurement

The financial statements have been prepared on the historical cost basis.

#### New accounting standards and interpretations

There are no amendments to accounting standards, or IFRIC interpretations, that are effective for the year ended 31 December 2022 that have a material impact on the company's financial statements.

- the requirements in IAS 24 Related Party Disclosures to disclose related party transactions entered into between two or more members of a group, provided that any subsidiary which is a party to the transaction is wholly owned by such a member;
- the requirements of paragraphs 130 (f) (ii) - 130 (f) (iii), 134(d) - 134(f) and 135(c), 135(e) of IAS 36 Impairment of Assets.

#### Interest receivable and payable

Interest income and expense are recognised in profit or loss using the effective interest rate ("EIR") method. The EIR is the rate that discounts the estimated future cash payments and receipts through the expected life of the financial asset or liability (or, where appropriate, a shorter period) to the carrying amount of the financial asset or liability. When calculating the effective interest rate, the Company estimates future cash flows considering all contractual terms of the financial instrument but not, in the case of financial assets, future credit losses.

The calculation of the effective interest rate includes all fees paid or received, transaction costs, and discounts or premiums that are an integral part of the effective interest rate. Transaction costs are incremental costs that are directly attributable to the acquisition, issue or disposal of a financial asset or financial liability.

Interest income and expense presented in the Profit and Loss Account and Other Comprehensive Income include interest on financial assets and financial liabilities at amortised cost on an effective interest rate basis.

#### Foreign currency transactions and balances

The accounts are presented in US dollars which is the company's functional and presentational currency.

Transactions in foreign currencies are recorded using a monthly average operating exchange rate. Monetary assets and liabilities denominated in foreign currencies are translated using the exchange rate ruling at the balance sheet date. The gains or losses arising are included in the Profit and Loss Account.

#### Tax

Tax is recognised in profit or loss, except that a change attributable to an item of income or expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the company operates and generates income, and any adjustments to tax payable in respect of previous years. Full provision is made for deferred tax liabilities arising from all temporary differences between the recognition of gains and losses in the financial statements and recognition in the tax computation.

A net deferred tax asset is recognised only if it can be regarded as probable that there will be suitable taxable profits from which the future reversal of the underlying temporary differences can be deducted. Deferred tax assets and liabilities are calculated at the tax rates expected to be effective at the time the temporary differences are expected to reverse.

Deferred tax assets and liabilities are not discounted.

### 2 Accounting policies (continued)

#### Financial instruments

##### Initial recognition

The company recognises financial assets and financial liabilities in the balance sheet when, and only when, the company becomes party to the contractual provisions of the financial instrument.

A financial asset (unless it is a trade debtor without a significant financing component) is initially measured at fair value plus, for an item not at fair value through profit or loss (FVTPL), transaction costs that are directly attributable to its acquisition or issue. A trade debtor without a significant financing component is initially measured at the transaction price.

Financial liabilities are initially recognised at fair value, representing the proceeds received net of premiums, discounts and transaction costs that are directly attributable to the financial liability.

##### Classification and subsequent measurement

Subsequent to initial measurement, financial assets and financial liabilities are measured at either amortised cost or fair value.

Financial instruments are classified at inception into one of the following categories, which then determine the subsequent measurement methodology:

Financial assets are classified into one of the following three categories:

- financial assets at amortised cost;
- financial assets at fair value through other comprehensive income (FVTOCI); or
- financial assets at fair value through the profit or loss (FVTPL).

Financial liabilities are classified into one of the following two categories:

- financial liabilities at amortised cost; or
- financial liabilities at fair value through the profit or loss (FVTPL).

The classification and the basis for measurement are subject to the company's business model for managing financial assets and liabilities and the contractual cash flow characteristics of the financial assets. Accordingly, all financial assets and liabilities are subsequently measured at amortised cost.

#### Financial instruments (continued)

##### Impairment of financial assets

The company recognises loss allowances for expected credit losses (ECLs) on financial assets measured at amortised cost, debt investments measured at FVTOCI and contract assets (as defined in IFRS 15).

The company measures loss allowances at an amount equal to lifetime ECL, except for other debt securities and bank balances for which credit risk (i.e. the risk of default occurring over the expected life of the financial instrument) has not increased significantly since initial recognition which are measured as 12-month ECL.

Loss allowances for trade receivables and contract assets are always measured at an amount equal to lifetime ECL.

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the company considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information and analysis, based on the company's historical experience and informed credit assessment and including forward-looking information.

Lifetime ECLs are the ECLs that result from all possible default events over the expected life of a financial instrument.

12-month ECLs are the portion of ECLs that result from default events that are possible within the 12 months after the reporting date (or a shorter period if the expected life of the instrument is less than 12 months).

The maximum period considered when estimating ECLs is the maximum contractual period over which the company is exposed to credit risk.

### 3 Critical accounting judgements and key sources of estimation uncertainty

The preparation of the financial statements requires the director to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities at the balance sheet date and the reported amounts of income and expenses during the year. Although these estimates are based on the directors best knowledge of the amounts, actual results ultimately may differ from those estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both the current and future periods.

In June 2021, the First Tier Tribunal decided against the company in relation to whether the UK or US has primary taxing rights over the company's income for the years 2003 to 2008. The company has appealed, and been granted permission to do so, to the Upper Tier Tribunal. The appeal was heard in early March 2023 and the judgement is expected to be handed down around three months from the hearing date. In November 2021, following the First Tier Tribunal decision, the company paid tax of £124,913,000 and interest of £63,717,000, equivalent to \$226,837,000 (2021: \$253,679,000), in respect of 2003 to 2008. As management are of the opinion that the company's appeal should succeed, the amount paid has been recorded as an amount receivable. See note 15 for further information.

#### 15 Contingent liabilities

The company is in dispute with HMRC regarding whether the UK or the US has primary taxing rights over the company's income for the years 2003 to 2008. In June 2021, the First Tier Tribunal decided against the company in relation to whether the UK or US has primary taxing rights over the company's income for the years 2003 to 2008. The company has appealed, and been granted permission to do so, to the Upper Tier Tribunal. The appeal was heard in early March 2023 and the judgement is expected to be handed down around three months from the hearing date. Management are of the opinion that it is more likely than not that the company will be successful in its appeal. Due to the uncertainty associated with this dispute, it is possible that the final outcome may differ from the position reflected in these financial statements. The impact on the company of an adverse final outcome would be based on the difference between interest paid on tax in the UK and received from the US tax authorities, plus foreign exchange differences that have arisen since the UK tax payment was made in 2021. The overall net loss in the event that the appeal is unsuccessful, measured at 31 December 2022, would be approximately \$9 million (2021: \$35 million).
