 - (a) moving clauses 3(a) and 3(b) to become clauses 4(a) and 4(b) respectively and renumbering existing clauses 4(a) to 4(m) (inclusive) as clauses 4(c) to 4(o) (inclusive);
 - (b) deleting the words "or indirectly" in both clause 5(j) and in clauses 5(m), 5(v) and 5(w); and
 - (c) replacing clause 5(r) with the following new clause 5(r):
 - "undertake obligations of every description and grant indemnities in relation to contractual obligations entered into by it;".

THAT the articles of association of the Company shall be amended by deleting article 6.3 and renumbering existing article 6.4 as article 6.3.
