

	ORDER	

UPON the application of the Applicants dated 13 November 2023 for a Block Transfer Order (the "**Application**")

AND UPON notice of the intention to make the Application having been delivered to the Secretary of State for Business and Trade ("the Secretary of State") on or before the date on which the Application was made pursuant to rule 12.37(6) of the Insolvency (England and Wales) Rules 2016 (the "Rules")

AND UPON there being evidence of service of the Application on the Respondent who is to be removed from office and any person holding office jointly with him pursuant to rule 12.37(7) of the Rules and the Respondent confirming his consent to the transfer of the cases identified in the Appointments Schedule attached to this order (the "Schedule")

AND UPON the Applicants inviting the Court to consider the Application without a hearing and the Court being satisfied that this is an appropriate case for a substantive order to be made on the Application without a hearing and the Court considering it expedient to make this order

AND UPON the Court having considered the witness statement of Russell David Parkin filed in support of the Application

IT IS ORDERED THAT:

- Each of the County Court cases listed in the Appointments Schedule be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies List ChD for the purposes only of making this application only.
- 2. Immediately upon this order taking effect, the County Court cases listed in the Appointments Schedule be transferred back to the County Court.
- From the date of this order, David Anthony Ingram (the "Outgoing Officeholder") be removed from office in respect of each of the cases listed in the Appointments Schedule (the "Block Transfer Cases").
- 4. Save to the extent the Block Transfer Cases only concern the removal of the Respondent, from the date of this order the Applicants be appointed as replacement officeholders (the "Replacement Officeholders") in respect of the Block Transfer Cases.
- 5. To the extent the Outgoing Officeholder is a party to proceedings in respect of any of the Block Transfer Cases, the Outgoing Officeholder will be automatically replaced by the relevant Replacement Officeholder(s) immediately upon this order taking effect.
- 6. Where the appointments referred to in this order are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
- 7. The Outgoing Officeholder shall apply to the Secretary of State for his release from all liability pursuant to the relevant sections of the Insolvency Act 1986 in respect of his acts or omissions and otherwise in respect of his conduct in relation to each of the cases in the Appointments Schedule, 21 days after giving notice to creditors in accordance with paragraph 10(b) of this Order.

- 8. Pursuant to rule 12.38(3) of the Rules, the Applicants must ensure that a sealed copy of this order is filed with the Court having jurisdiction over each Block Transfer Case affected by this order.
- 9. Pursuant to rule 12.38(6) of the Rules, the Replacement Officeholder shall give written notice of their appointment to the Secretary of State in all cases and also to the Registrar of Companies in the cases of the liquidations included in the Appointments Schedule.
- 10. Pursuant to rule 12.38(6) of the Rules, the Replacement Officeholders and any continuing officeholder shall give written notice of this order to the creditors in all Block Transfer Cases as follows:
 - a) in the next progress report; and
 - b) by way of one composite advertisement in the London Gazette within 28 days of the date of this order.

such notices to include an explanation of the effect of this order and express reference to the liberty to apply.

- 11. The creditors in all Block Transfer Cases in the Appointments Schedule are permitted to apply to set aside or vary this order within 21 days of either:
 - a) this order being published in the London Gazette; or, if necessary,
 - b) the sending of the progress report (if it is due within three months of the date of this order).

Such application shall not affect the transfer of the cases listed in the Appointments Schedule until further or other order by the Court.

- 12. This order having been made without a hearing, any person other than the creditors described in the paragraph above may apply to set aside or vary this order within seven days of service upon them.
- 13. The costs of this Application (including the obtaining of an Insolvency Practitioner's licence bond and advertisement in the London Gazette) shall be paid by Grant Thornton UK LLP without recourse to the estates of the Block Transfer Cases, directly or indirectly to the estates listed in the Schedule.
- 14. Subject to paragraph 13 above, in the event that, as a result of the order Grant Thornton UK LLP incurs and additional cost in respect of the administration of those estates where the Respondent was the officeholder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by Grant Thornton UK LLP and shall not be charges as an expense of the administration of those estates.

15. To the extent that any of the Block Transfer Cases are closed at the date the notice referred to in paragraph 10(b) above is published, the terms of this order shall not apply.
