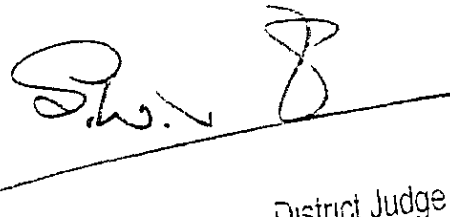
IT IS ORDERED THAT

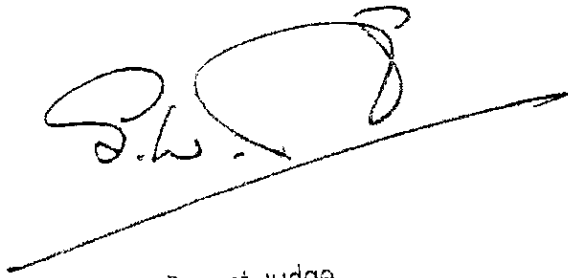
