That the directors of the Company be and they are hereby empowered pursuant to section 570 of the Companies Act 2006 to allot equity securities (within the meaning of section 560 of that Act) pursuant to the authority conferred by the ordinary resolution numbered 1 above as if section 561 of that Act did not apply to such allotment provided that this power shall cease to have effect when the said authority is revoked or would, if not renewed, expire save that the Company may before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry.

3. Special Resolution

That the regulations set out in the document produced to the meeting and, for the purposes of identification, initialled by the chairman be adopted as the article of association of the Company in substitution for all existing articles of association of the Company.
