We resign as auditors of the Companies listed in Appendix 1 for which we are auditors, with effect from the date of this letter.

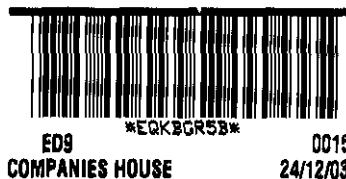
