This Assignment will become enforceable if any of these events occur:

16. Our power to remedy

- 31.7 any insurer who is or who proposes to provide insurance to us in respect of the Debt; and
- 31.8 any affiliates or professional advisers of any of the above persons.

34. Counterparts

This Assignment may be executed in any number of counterparts and this has the same effect as if the signatures on the counterparts were on a single copy of this Assignment.

35. Third party rights

35.1 Unless expressly provided to the contrary in this Assignment, a person who is not a party to this Assignment has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce, or enjoy the benefit of, any term of this Assignment.

35.2 The consent of any person who is not a party to this Assignment is not required to rescind or vary this Assignment at any time.

36. Governing law & jurisdiction

36.1 If the Agreement is governed by English law, then English law governs this Assignment, its interpretation and any non-contractual obligation arising from or connected with it. If the Agreement is governed by the laws of Northern Ireland, then the laws of Northern Ireland govern this
 Assignment, its interpretation and any non-contractual obligation arising from or connected with it.

36.2 We and you submit to the exclusive jurisdiction of the courts of (i) England and Wales (if the Agreement is governed by English law), or (ii) Northern Ireland (if the Agreement is governed by the laws of Northern Ireland), in relation to all matters (including non-contractual) arising from or in connection with this Assignment.
