TO ALL MEMBERS, CREDITORS AND THE REGISTRAR OF COMPANIES

1 INTRODUCTION

- 1.1 Martin Maloney and John Titley were appointed Joint Liquidators of Debt Connect (U.K.) Limited ("the Company") on 28 October 2014.
- Mr Titley retired from practice and agreed to transfer the management of his insolvency caseload to other appropriate insolvency practitioners within Leonard Curtis. In accordance with Rules 12.36 and 12.37 of the Insolvency (England and Wales) Rules 2016 ("the Rules") therefore, an application was made to Court for an Order to remove Mr Titley as Insolvency Practitioner on each of his cases and replace him with Steve Markey of Leonard Curtis. The Order was granted by the Court on 31 May 2019. Accordingly, Mr Titley ceased to act as Joint Liquidator of this case on 31 May 2019 and Steve Markey was appointed in his place.
- 1.3 Martin Maloney and Steve Markey are authorised to act as insolvency practitioners in the UK by the Institute of Chartered Accountants in England and Wales.
- 1.4 This report provides an update on the conduct of the Liquidation for the period from 28 October 2019 to 27 October 2020, as required by Section 104A(1) of the Insolvency Act 1986 (as amended) ("the Act") and Rule 18.3 of the Rules. It contains details of the progress made, the expected outcome for creditors and other information that the Joint Liquidators are required to disclose and should be read in conjunction with the previous progress report dated 20 December 2019.
- 1.5 All figures are stated net of VAT.

2 CONDUCT OF THE LIQUIDATION

2.1 The Company's registered office was changed to Leonard Curtis Hollins, Mount Hollins Lane, Bury BL9 8DG on 6 November 2014. This was subsequently changed to Leonard Curtis House, Elms Square, Bury New Road, Whitefield, Greater Manchester M45 7TA on 30 June 2015.

Assets Realised

Funds from Manolete

As detailed in previous reports, the Joint Liquidators are investigating antecedent transactions which occurred prior to the Liquidation. Sufficient information and funding has been obtained to continue the investigation. During the period of this report, funding of £2,500 has been received from Manolete Partners ("Manolete"). The Joint Liquidators and Manolete have been in correspondence with the directors and their representatives in relation to these antecedent transactions to resolve the matter as soon as possible. Further information will be provided in due course.

Bank Interest

2.3 Bank interest of £3 has been received in the period.

Assets Still to be Realised

2.4 There are no assets still to be realised. Once the antecedent transactions have been investigated and any appropriate further realisations have been made, this case will be progressed to closure.

3 RECEIPTS AND PAYMENTS ACCOUNT

3.1 A summary of the Joint Liquidators' receipts and payments for the entire period of the Liquidation, including the period from 28 October 2019 to 27 October 2020, is attached at Appendix A.

4 OUTCOME FOR CREDITORS

Secured Creditors

4.1 Lloyds TSB Bank Plc ("Lloyds") hold a debenture deed incorporating a fixed charge and a floating charge created on 19 November 2007 and registered on 24 November 2017. It is understood that no liability was outstanding to Lloyds at the date of Liquidation.

Preferential Creditors

- 4.2 As at the date of Liquidation, there were 21 preferential creditors, with estimated claims totalling £16,800.
- 4.3 No claims have been received.

Prescribed Part

4.4 As the Company has no unsatisfied post-Enterprise Act charges, there is no requirement to set aside a prescribed part in this case.

Ordinary Unsecured Creditors

- As at the date of Liquidation, there were 21 unsecured creditors, with estimated claims totalling £141,042. Claims totalling £149,696 have been received.
- 4.6 The funds realised have already been distributed or used or allocated for paying the expenses of the Liquidation. As a result, there will be no dividend to ordinary unsecured creditors.
- 4.7 The Joint Liquidators have collated and acknowledged (where requested) the claims of the ordinary unsecured creditors, although, in view of the fact that there will be no distribution to this class of creditor, unsecured claims have not been formally agreed.

5 INVESTIGATIONS

A previously reported, following the initial assessment, detailed investigations were required by the Joint Liquidators relating to the Company. These investigations are still continuing and the Joint Liquidators have instructed Ward Hadaway solicitors to provide assistance with the investigations.

JOINT LIQUIDATORS' REMUNERATION, EXPENSES AND DISBURSEMENTS, AND CREDITORS' RIGHTS

Remuneration

A fee of £12,500 for the preparation of the statement of affairs was approved by creditors on 28 October 2014. Included within this amount is £1,500 which will be paid to Maddison's Accountants, for their assistance with the preparation of the statement of affairs. To date, no fees have been drawn.

- At the same meeting, it was resolved that the Joint Liquidators' remuneration be payable by reference to time properly given by them and their staff in attending to matters arising in the Liquidation. The Joint Liquidators' time costs from 28 October 2019 to 27 October 2020 are £12,982, which represents 34 hours at an average hourly rate of £381.82. Attached at Appendix B is a time analysis which provides details of the activity costs incurred by staff grade during the period from 28 October 2019 to 27 October 2020. Total time costs from the commencement of the Liquidation amount to £88.811.
- 6.3 To date, no fees have been drawn.
- Due to ongoing investigations, as per paragraph 2.2, significant time has been spent progressing and reviewing the case.

Significant Time Costs

Assets

Time has been incurred by the Joint Liquidators, and their staff, in realising the assets of the Company. As detailed above and in previous reports, this is due to significant time spent progressing the investigation into certain antecedent transactions.

Expenses and Disbursements

- A summary of the Joint Liquidators' expenses from 28 October 2014 to 27 October 2020 is attached at Appendix C. To assist creditors' understanding of this information, it has been separated into the following two categories:
 - Standard Expenses: this category includes expenses payable by virtue of the nature of the Liquidation process and / or payable in order to comply with legal or regulatory requirements.
 - Case Specific Expenses: this category includes expenses likely to be payable by the Joint
 Liquidators in carrying out their duties in dealing with issues arising in this particular Liquidation.
 Included within this category are costs that are directly referable to the Liquidation but are not
 paid to an independent third party (and which may include an element of allocated costs). These
 are known as 'category 2 disbursements' and they may not be drawn without creditor approval.
- 6.7 Authority to take category 2 disbursements was approved by members on 28 October 2014.
- Attached at Appendix D is additional information in relation to the firm's policy on staffing, the use of subcontractors, disbursements and details of current charge-out rates by staff grade. Please be aware that the firm's charge out rates have been amended with effect from 1 August 2019.
- During the period of this report, no further professional advisors ("PA") or subcontractors ("S") have been instructed:

Creditors' Rights

6.10 Under Rule 18.9 of the Rules, within 21 days of receipt of this report, a secured creditor, or an unsecured creditor with either the concurrence of at least five per cent in value of the unsecured creditors (including the creditor in question), or with the permission of the court, may request in writing that the Joint Liquidators provide further information about their remuneration or expenses which have been itemised in this report.

- Under Rule 18.34 of the Rules, any secured creditor, or any unsecured creditor with either the concurrence of at least 10 per cent in value of the unsecured creditors (including that creditor), or the permission of the court, may within eight weeks of receipt of the progress report that first reports the fee basis, the charging of the remuneration or the incurring of the expenses in question, make an application to court on the grounds that, in all the circumstances, the basis fixed for the Joint Liquidators' remuneration is inappropriate and/or the remuneration charged or the expenses incurred by the Joint Liquidators, as set out in the progress report, are excessive.
- Unless the court orders otherwise, the costs of the application shall be paid by the applicant and are not payable as an expense of the Liquidation.

 - The realisation of the remaining asset, as detailed in section 2; and
 - Preparation of the Final Account.

Disbursements

It will be used to enable us to assess the extent of the insolvent entity's liabilities, to allow you to vote on any decision procedures, to enable us to communicate with you, to process your claim and to pay any dividends which may be due to you from the insolvent estate.

Who we share your information with

We may be required to share some of your Personal Data with other creditors. The data which will be shared with other creditors will be limited to that specifically required to be disclosed under insolvency legislation.

We may share some of your information with our Data Processors. Data Processors include solicitors, accountants and employment law specialists who assist us with our duties where required. We will only share your information with our Data Processors if we require their specialist advice. All of our Data Processors are subject to written contracts with us to ensure that your Personal Data is processed only in accordance with the GDPR.

How long will we hold your Personal Data for?

We will need to hold your Personal Data for a period of time after the insolvency has been concluded. This is to enable us to deal with any queries which might arise. Our Records Management Policy requires us to destroy our physical files 6 years after closure of the case. Electronic data files will be removed from our Case Management System 6 years after conclusion of the case but may be held on our server for a longer period of time but with restricted access.

Your rights in respect of your Personal Data

You have the right to request access to your Personal Data and to require it to be corrected or erased. You also have the right to request a restriction in the way we process your Personal Data or to object to its processing. You should be aware however that we may not be able to comply with your request if this would affect our ability to comply with our legal obligations.

You have the right to Data Portability. This is a right to have the Personal Data we hold about you to be provided to you in a commonly used and machine-readable format so that you can transfer that Data to another organisation in a way that is not too onerous to upload the Data.

Your right to complain

You have the right to be confident that we are handling your Personal Data responsibly and in line with good practice. If you have a concern about the way we are handling your Personal Data you should contact our Privacy Manager in the first instance.
