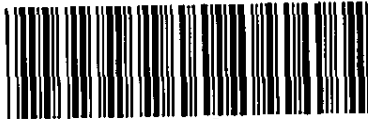

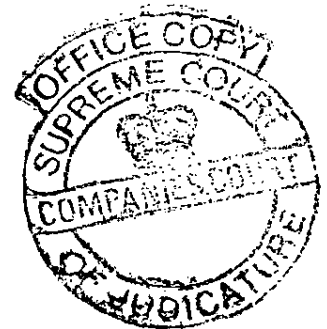

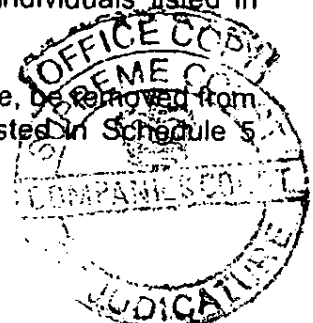
ORDER

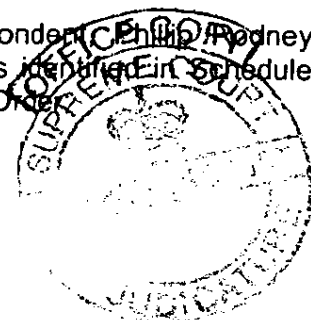
And **UPON READING** the documents on the Court File recorded as having been read.

IT IS ORDERED:

1. That the Applicant has leave to make a composite application in respect of the insolvency proceedings identified in the Schedules numbered 1 to 12 attached to this Application ("the Schedules").
2. That the proceedings listed in Schedules 1 to 12 attached hereto be transferred to the Companies Court of the Chancery Division of The Royal Courts of Justice for the purpose only of this application, and the First and Second Respondents do ensure that a sealed copy of every order transferring any case to this Court and of every order which may be made as a result of this application be lodged with the court having jurisdiction over each case affected by such order for filing on the court file relating to that case.
3. That the First and Second Respondents do procure that a sealed copy of any such order is lodged at any District Registry where a case listed in Schedules 1 to 12 is pending.
4. That the time for service of this application be abridged to permit the application to be heard at such time as this court shall think fit.
5. Pursuant to paragraph 88 of Schedule B1 to the Insolvency Act 1986 (the "Act") the Applicant, Nigel Price, be removed from his office as joint administrator of the companies listed in Schedules 1 and 2 hereto as being in administration;
6. Pursuant to paragraph 63 of Schedule B1 to the Act the First Respondent, Phillip Rodney Sykes, shall remain as sole administrator of the company listed in Schedule 1 hereto as being in administration;
7. Pursuant to paragraph 63 of Schedule B1 to the Act the Third Respondent, Simon Geoffrey Paterson, shall remain as sole administrator of the companies listed in Schedule 2 hereto as being in administration;
8. Pursuant to paragraph 88 of Schedule B1 to the Act the Applicant, Nigel Price, be removed from his office as sole administrator of the companies listed in Schedule 3 hereto as being in administration;
9. Pursuant to paragraph 63 of Schedule B1 to the Act the First and Second Respondents, Phillip Rodney Sykes and David Alan Rolph, be appointed as joint administrators of the companies listed in Schedule 3 hereto as being in administration;
10. Pursuant to section 298(1) of the Act the Applicant, Nigel Price, be removed from his office as sole trustee in bankruptcy of the individuals listed in Schedule 4 hereto;
11. Pursuant to section 303(2) of the Act the First Respondent, Phillip Rodney Sykes, be appointed as sole trustee in bankruptcy of the individuals listed in Schedule 4 hereto;
12. Pursuant to section 298(1) of the Act the Applicant, Nigel Price, be removed from his office as sole trustee in bankruptcy of the individuals listed in Schedule 5 hereto;

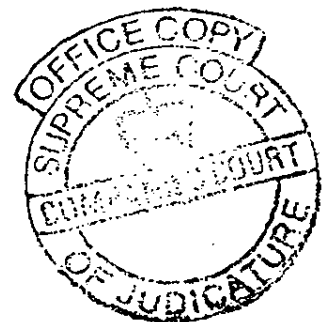


13. Pursuant to section 303(2) of the Act the Second Respondent, David Alan Rolph, be appointed as sole trustee in bankruptcy of the individuals listed in Schedule 5 hereto;
14. Pursuant to section 298(1) of the Act the Applicant, Nigel Price, be removed from his office as joint trustee in bankruptcy of the individuals listed in Schedule 6 hereto;
15. Pursuant to section 303(2) of the Act the Second Respondent, David Alan Rolph, be appointed as joint trustee in bankruptcy of the individuals listed in Schedule 6 hereto;
16. Pursuant to section 108(2) of the Act the Applicant, Nigel Price, be removed from his office as sole liquidator of the companies identified in Schedule 7 hereto as being in Creditors' Voluntary Liquidation;
17. Pursuant to section 108(2) of the Act the First and Second Respondents, Phillip Rodney Sykes and David Alan Rolph, be appointed as joint liquidators of the companies listed in Schedule 7 hereto as being in Creditors' Voluntary Liquidation;
18. Pursuant to section 108(2) of the Act the Applicant, Nigel Price, be removed from his office as joint liquidator of the companies identified in Schedule 8 hereto as being in Creditors' Voluntary Liquidation;

20. Pursuant to section 263(4) of Act the Applicant, Nigel Price, be removed from his office as sole supervisor of the Individual Voluntary Arrangements identified in Schedule 9 hereto;
21. Pursuant to section 263(5) of the Act the First Respondent, Phillip Rodney Sykes, be appointed as sole supervisor of the Individual Voluntary Arrangements identified in Schedule 9 hereto;
22. Pursuant to section 108(2) of the Act the Applicant, Nigel Price, be removed from his office as sole liquidator of the companies identified in Schedule 10 hereto as being in Members' Voluntary Liquidation;
23. Pursuant to section 108(2) of the Act the First and Second Respondents, Phillip Rodney Sykes and David Alan Rolph, be appointed as joint liquidators of the companies listed in Schedule 10 hereto as being in Members' Voluntary Liquidation;
24. Pursuant to section 172(2) of the Act the Applicant, Nigel Price, be removed from his office as sole liquidator of the companies identified in Schedules 11 to 12 hereto as being subject to a Compulsory Winding-Up Order;
25. Pursuant to section 168(3) of the Act the First Respondent, Phillip Rodney Sykes, be appointed as sole liquidator of the companies identified in Schedule 11 hereto as being subject to a Compulsory Winding-Up Order;



26. Pursuant to section 168(3) of the Act the Second Respondent, David Alan Rolph, be appointed as sole liquidator of the companies identified in Schedule 12 hereto as being subject to a Compulsory Winding-Up Order;
27. The Applicant be released from all liability in respect of acts and omissions of his in the administration of the companies listed in Schedules 1 to 3 hereto as being in administration and in relation to his conduct as officeholder of the companies listed in Schedules 1 to 3 hereto with effect from 28 days after the relevant notice referred to in paragraph 28 below has been advertised, save in respect of any claim notified to the Applicant or (where appropriate) his joint appointee or replacement officeholder by that date pursuant to the Act and/or pursuant to such other provisions as may apply;
28. Where the Act or the Insolvency Rules 1986 requires the removal of the Applicant and/or the appointment of the First and Second Respondents to be advertised, the First and Second Respondents shall in accordance with the Insolvency (Amendment) Rules 2009 procure that, at the first convenient opportunity to do so, and in any event within 3 months of the date of this Order, a block advertisement in relation to each of the estates shall be placed in the London Gazette and may be advertised in such other manner as the First and Second Respondents think fit containing notification of the following matters:
- a) the removal of the Applicant and the appointment of, and the name of his replacement;
 - b) the fact that the creditors have liberty to apply, within 28 days after the notice has been advertised, to vary or discharge the Order made;
 - c) in the case of each bankruptcy and liquidation, that:
 - i. the costs of complying with a request of the committee or creditor for an account of the Applicant's administration should be an expense of the insolvency proceedings;
 - ii. the fact that the creditors have the right to object and make representations to the Secretary of State in respect of the Applicant's release within 28 days after the notice has been advertised; and
 - iii. the fact that the Applicant will be entitled to apply to the Secretary of State for his release 42 days after the notice has been advertised;
29. The Applicant shall not be at liberty to apply to the Secretary of State for his release from his position as liquidator (whether voluntary or compulsory) or as trustee in bankruptcy until after the expiry of 42 days from the date when the relevant notice referred to in paragraph 28 above has been made to the creditors of the relevant estate;
30. The costs of this Application be apportioned equally between each of the estates identified in Schedules 1 to 12 hereto and each of the said estates shall bear an equal proportion of the costs;
31. In no case shall the amount charged to any estate in respect of the costs exceed 10 per cent of the aggregate of available funds and the value of the immediately realisable assets in that estate; and

32. Further or other directions and relief as the court thinks fit.
