

#### **ORDER**

**UPON** the application of Stephen Paul Grant, Louise Mary Brittain and Meghan Andrews herein filed on 21 May 2021.

AND UPON READING the written evidence filed

**AND UPON** the Applicants' solicitors having confirmed that notice of this Application has been given to the Secretary of State

#### IT IS ORDERED THAT:

- the County Court proceedings listed in the Schedule hereto be transferred to the High Court solely for the purpose of and insofar as is necessary for considering the Application and the making of this order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this order;
- in respect of each administration listed in Schedule A attached hereto, pursuant to paragraphs 88 and 91(2)(c) of Schedule B1 to the Insolvency Act 1986 and rule 12.36(2) of the Insolvency Rules 2016:
  - a. Matthew John Waghorn be removed as administrator;
  - b. Meghan Andrews be appointed as administrator.
- in respect of each creditors' voluntary liquidation listed in Schedule B attached hereto, pursuant to sections 108 and 171 of the Insolvency Act 1986 and rule 12.36(2) of the Insolvency Rules 2016:
  - a. Matthew John Waghorn be removed as liquidator;

- b. The Insolvency Practitioner detailed in Schedule B, being either Stephen Paul Grant, Louise Mary Brittain or Meghan Andrews be appointed as liquidator.
- in respect of each members' voluntary liquidation listed in Schedule C attached hereto, pursuant to sections 108 and 171 of the Insolvency Act 1986 and rule 12.36 of the Insolvency Rules 2016:
  - a. Matthew John Waghorn be removed as liquidator;

- the effect of rules 18.3, 18.4, 18.6 18.10 of the Insolvency (England and Wales) Rules 2016 be suspended so that the appropriate dates in respect of each officeholder's reporting obligations be unaffected by this application and that in each case the dates shall remain the same as they would have been had this application not been made;
- insofar as Matthew John Waghorn was a joint officeholder, unless otherwise already provided the incoming officeholder may exercise all powers jointly with the co-officeholders or separately;
- there be no order as to costs (costs are to be borne by Azets);
- a copy of this order be delivered as soon as reasonably practicable to the Secretary of State.
