


No statement of comprehensive income or statement of changes in equity has been prepared as the Company has not traded during the year or the preceding financial year. The Directors received no remuneration.

### Notes to the Financial Statements For the Year Ended 31 December 2019

#### 1. Reporting entity

Barclays Direct Investing Nominees Limited (the 'Company') is a dormant private limited company domiciled and incorporated in England. The Company's registered office is at 1 Churchill Place, London, E14 5HP. The financial statements are prepared for the Company only, in line with the Act. The Company is a wholly owned subsidiary of Barclays Investment Solutions Limited and its ultimate parent company is Barclays PLC, which prepares consolidated financial statements in accordance with International Financial Reporting Standards ('IFRSs') and interpretations ('IFRICs') issued by the IFRS Interpretations Committee, as published by the International Accounting Standards Board ('IASB'). They are also in accordance with IFRS and IFRIC interpretations endorsed by the European Union.

#### 2. Basis of preparation

These financial statements have been prepared in accordance with International Financial Reporting Standards, International Accounting Standards and Interpretations (collectively IFRSs). They were authorised for issue by the Company's board of Directors on 08 July 2020.

#### 3. Functional and presentation currency

These financial statements have been prepared under the historical cost convention and are presented in pound sterling (£), which is the Company's functional currency. All amounts have been rounded to the nearest pound, unless otherwise indicated.
