#### 1. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

No advances were made during the financial year to the directors, Mr M D Roberts and Mr S M Roberts. At the financial year end, Mr M D Roberts was owed £20,085 (2016 - £22,079) and Mr S M Roberts was owed £5,773 (2016 - £16,462). The loans are unsecured, interest free and repayable on demand.

#### 2. OTHER FINANCIAL COMMITMENTS

Bank loans totalling £137,996 (2016 - £142,955) are secured on a fixed and floating charge over the freehold property owned by the company.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 January 2017 in accordance with Section 476 of the Companies Act 2006.
