In the fourth year of it's existence Beyond Mind limited continued with the established work in teaching and mental health act assessment and medico legal work.

The aimed psychotherapeutic practise did not materialise that easily. Further efforts in the future have to be directed towards securing practice rooms. One goal is to allocate back to London and establish such a private work environment.
