1. ACCOUNTING POLICIES

BASIS OF PREPARING THE FINANCIAL STATEMENTS

The financial statements have been prepared under the historical cost convention and in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006.

This is the first year that the company has presented its financial statements under Section 1A "Small Entities" of Financial Reporting Standard 102 (FRS 102 Section 1A) issued by the Financial Reporting Council. The last financial statements, for the year ended 30th June 2016, were prepared under previous UK GAAP. The transition date to FRS 102 Section 1A is therefore 1 July 2015.

Adopting FRS 102 Section 1A has not resulted in any changes to the company's existing accounting policies which were applied prior to transition. There was no change to the reported profit and loss account or closing equity position of the company for the year ended 30th June 2016 as a result of the transition, nor to the opening equity position at the date of transition.

2. DIRECTORS' RESPONSIBILITIES
