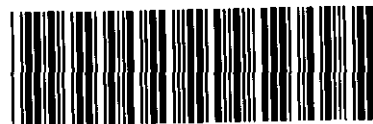



- f) part with or share possession or occupation of any of its Land

Note 2 The Debenture gives the Bank power to appoint an Administrator
