Notes to the Financial Statements for the Year Ended 31 December 2016

1 Principal accounting policy

The Company's financial statements have been prepared in compliance with United Kingdom Accounting Standards, including Financial Reporting Standard 102, 'The Financial Reporting Standard applicable in the United Kingdom and the Republic of Ireland' ("FRS 102") and the Companies Act 2006.

FRS 102 allows an entity to apply certain recognition and measurement exemptions to standard requirements. The entity being dormant, it has applied the exemptions available under the standard which allows a Company to 'retain its accounting policies for reported assets, liabilities and equity at the date of transition until there is any change to those balances or the Company undertakes any new transactions'.

6 Future developments

On 18 January 2017 the Company changed its name from Centrica (DSW) Limited to Distributed Energy Customer Solutions Limited. The Company is now a trading entity for Centrica's UK Distributed Energy business. Prior to the name change the Company was a dormant entity, but since becoming Distributed Energy Customer Solutions Limited it has been trading to provide customers with onsite energy generation solutions, energy insights and asset optimization services. Distributed Energy is one of Centrica's key growth businesses and is supported by investment from Centrica plc.

7 Ultimate parent undertaking

Centrica Renewable Energy Limited, a company registered in England and Wales, is the immediate parent undertaking. Centrica plc, a company also registered in England and Wales, is the ultimate parent undertaking.
