### 2. DURATION

I declare that this Power of Attorney shall be irrevocable until 31 August 2004 and shall be conclusively binding on myself and my personal representatives in favour of third parties who have not received notice of revocation.

#### 3. JURISDICTION

This Power shall be governed by and construed in accordance with English law and is subject to the exclusive jurisdiction of the English Courts.
